SHPO understands that the Town of Marlborough intends to construct a water system that will provide public water to an area currently supplied by individual wells and non-community public water systems.

The proposed project corridor is adjacent to the Marlborough Tavern, a property listed on the National Register of Historic Places. In order to complete our review, additional information is needed. Please submit to our office more detailed plans, including the approximate locations of all proposed ground disturbing activities and additional information regarding the use of existing utility corridors, if any.

The State Historic Preservation Office (SHPO) reviewed the referenced project in response to a Scoping Notice posted on the Environmental Monitor. At the request of this office, additional information was provided by the Department of Public Health on June 10, 2014 to assist in completing our review. SHPO understands that the Town of Marlborough intends to construct a water system that will provide public water to an area currently supplied by individual wells and non-community public water systems.

As noted in our previous correspondence, the proposed project corridor is adjacent to the Marlborough Tavern, a property listed on the National Register of Historic Places. Project plans in the vicinity of the tavern indicate that the proposed water main installation will be within the road or adjacent to it in areas already impacted by underground utilities and sidewalks. It is unlikely that the proposed undertaking would impact intact significant archeological deposits. In addition, because the proposed installation does not impact the character defining features of the property, there will be no adverse effect to the historic property named above.
