In accordance with Sections 10-283 and 10-283a of the Connecticut General Statutes, I hereby request authorization to enter into grant commitments for each project on the attached 2002 School Building Project Priority Category List. Each project has been placed into one of three priority categories as defined in Section 10-283. Individual project category placement has been determined by a review of the application and educational specifications submitted for each project.

Projects for permanent building additions and interior alterations have been reviewed for inclusion of technology infrastructure improvements. Unless otherwise noted in the Table 2 project description, a project does address technology.

Table 1 is an alphabetical listing of all projects, by category, including the amount of each estimated project grant. Table 2 is a brief description of each of the projects on the Priority List. Table 3 is a summary analysis of the Priority Lists for the current and past five years. Table 4 is a supplemental schedule of those projects previously approved by the Governor and the General Assembly for which costs or project scope have changed to a significant degree.

The project costs shown in these tables are estimated and are based upon preliminary documents. We have asterisked several projects that have costs or programmatic issues still under review. We will forward any data changes resulting from our review by January 15, 2002. These documents generally include initial schematic designs and first cost estimates by architects based on such designs. While these costs should still be considered preliminary, we do require verification of the cost estimates by a qualified independent professional with experience in construction cost estimating. It typically takes three to six years from the time of preliminary estimates until projects are fully completed and final costs, on the basis of which final grant calculations are made, will be known. There are usually several changes from initial estimates to actual final costs and, therefore, estimates of both costs and associated grants are subject to change.

Prior to February 1 of each year, you are required by Section 10-283a to submit an approved or modified listing of priority projects to the Governor and General Assembly.

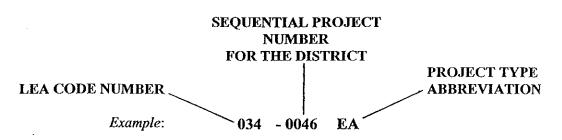

043-0228 MAG/N, East Hartford, East Hartford/Glastonbury Magnet

Projected Enrollment: 420 Grade Range: PreK-5 Projected Final Floor Area (In Square Feet): 101,000

Total Estimated Project Cost: \$36,631,310

This project is for the contruction of a new interdistrict magnet school with a focus on science, technology, and global education (Japanese). This project replaces a facility currently being leased in the town of East Hartford. It also includes the purchase of land (parcel yet to be determined) for the site. Project costs are currently undergoing department review. Any modifications to the reported cost will be forwarded to the Education Committee prior to January 15, 2002.

064-0279 MAG/N, Hartford, Sports Science Magnet High School

Projected Enrollment: 725 Grade Range: 7-12 Projected Final Floor Area (In Square Feet): 175,000

Total Estimated Project Cost: \$67,648,775

This project is for the contruction of a new facility to house a program which is currently operating as a charter school in Hartford. The project also includes the purchase of land at a yet to be determined site. The district has applied for consideration as an interdistrict regional magnet school. The operating plan is pending review and approval by the Department. Project costs are currently undergoing department review. Any modifications to the reported cost will be forwarded to the Education Committee prior to January 15, 2002.

093-0341 MAG/N, New Haven, Magnet Co-op Arts/Humanities High School

Projected Enrollment: 500 Grade Range: 9-12 Projected Final Floor Area (In Square Feet): 166,894

Total Estimated Project Cost: \$50,986,219

This project is for the construction of a new facility for the Magnet Cooperative Arts/High School to replace the existing facility which the program has outgrown. The project also includes the purchase of a site. The expanded operating plan for the magnet is pending review and approval by the Department. Project costs are currently undergoing department review. Any modifications to the reported cost will be forwarded to the Education Committee prior to January 15, 2002.

095-0078 MAG/EA, New London, Science and Technology Magnet High School

Projected Enrollment: 250 Grade Range: 9-12 Projected Final Floor Area (In Square Feet): 62,960

Total Estimated Project Cost: \$29,092,100

This project is for the addition of 62,960 square feet and minor alterations to the existing New London High School for the creation of a new interdistrict magnet school with a science and technology based curriculum. The district has applied for consideration as an interdistrict regional magnet school. The operating plan is pending review and approval by the Department. Project costs are currently undergoing department review. Any modifications to the reported cost will be forwarded to the Education Committee prior to January 15, 2002.

Priority Category A (con't.)

103-0212 MAG/E, Norwalk, Global Studies Magnet School

Projected Enrollment: 400 Grade Range: 9-12 Projected Final Floor Area (In Square Feet): 28,420

Total Estimated Project Cost: \$8,435,569

This project is for the addition of 28,420 square feet to the Brien McMahon High School for expansion of the current Center for Japanese Studies Abroad magnet school program with an emphasis on Chinese/Pacific Rim studies. The Center for Global Studies Magnet School is likely to expand to include Latin American studies in the near future. The operating plan for the expanded magnet school has been approved by the Department. Project costs are currently undergoing department review. Any modifications to the reported cost will be forwarded to the Education Committee prior to January 15, 2002.

253-0089 MAG/N, EastConn, PreK-K Magnet School

Projected Enrollment: 342 Grade Range: PreK-K Projected Final Floor Area (In Square Feet): 42,408

Total Estimated Project Cost: \$14,499,687

This project is for the contruction of a new facility to meet regional need for full-day kindergarten, to reduce racial isolation in the region, and to accommodate increasing demand in area towns for pre-kindergarten services. The project also includes the purchase of land. The district has applied for consideration as an interdistrict regional magnet school. Where EastConn is the current applicant of record, the application may be resubmitted by one of the participating towns. The operating plan is pending review and approval by the Department.

900-0005 EA, State Vocational Technical School System, E. C. Goodwin V. T. School

Projected Enrollment: 890 Grade Range: 9-12
Projected Final Floor Area (In Square Feet): 226,963

Total Estimated Project Cost: \$53,798,000

This project is for the addition of 50,019 square feet and alterations to accommodate increasing enrollment and program changes with facility upgrade due to general age/condition and upgrade of facility to current voice, data and video technology standards. The project will also include the correction of code violations, hazardous material abatement and replacement of exterior curtain walls with insulated masonry wall construction for energy conservation.

900-0006 EA, State Vocational Technical School System, W. F. Kaynor V. T. School

Projected Enrollment: 865 Grade Range: 9-12 Projected Final Floor Area (In Square Feet): 210,995

Total Estimated Project Cost: \$53,325,000

This project is for demolition of 16,375 square feet, the addition of 81,988 square feet, and alterations to accommodate increasing enrollment and program changes with facility upgrade due to general age and condition. The project will also include the correction of code violations, hazardous material abatement and window replacement for energy conservation.

015-0137 N, Bridgeport, New High School

Projected Enrollment: 2,000 Grade Range: 9-12 Projected Final Floor Area (In Square Feet): 368,264

Total Estimated Project Cost: \$112,210,554

This project is for the contruction of a new high school to accommodate increasing enrollment. The project will also include the purchase of land.

023-0026 EA, Canton, Canton Intermediate School

Projected Enrollment: 422

Grade Range: 4-6

Projected Final Floor Area (In Square Feet): 58,300

Total Estimated Project Cost: \$5,480,005

This project is for the addition and alteration of an 8,800 square feet area for 8 new classrooms to accommodate increasing enrollment, program changes, correction of code violations, upgrading the facility to current voice, video, and telecommunication technology, and facility upgrade due to general age and condition.

023-0028 EA, Canton, Junior/Senior High School

Projected Enrollment: 828

Grade Range: 7-12

Projected Final Floor Area (In Square Feet): 177,750

Total Estimated Project Cost: \$17,135,175

This project is for the addition of 40,000 square feet and alterations to accommodate increasing enrollment, program changes, correction of code violations, and upgrading the facility to current voice, video, and telecommunication technology.

025-0090 E, Cheshire, Dodd Middle School

Projected Enrollment: 842

Grade Range: 7-8

Projected Final Floor Area (In Square Feet): 122,270

Total Estimated Project Cost: \$2,000,000

This project is for the addition of 8,650 square feet to accommodate increasing enrollment. An application for the interdistrict attendance reimbursement bonus pursuant to Section 10-285a(g), that would increase the reimbursement percentage by up to 10 percentage points, has been received and is pending final approval. The reimbursement percent noted in Table 1 does not include the bonus at this time.

027-0053 EA, Clinton, Lewin G. Joel Jr. School
