This application is used to request authorization from the State of Connecticut for a permit to film or take photographs on property owned by the State of Connecticut including but not limited to all state roads and highways, railroads and rail stations, state forests and parks, airports, and seaports, hospitals and all the campuses of the public institutions of higher education and any other state owned real or personal property except courthouses and Judicial Branch facilities. The Office of Film, Television & Digital Media will serve as your liaison to the relevant state agencies with regard to state regulations, insurance requirements and location fees.

The Office of Film, Television & Digital Media will also assist your production in obtaining the needed permits and permissions from the state's 169 municipalities.
