Subscriber Agreement Instructions



Purpose

The CT DEEP Subscriber Agreement applies to all filings using an electronic signature, as an alternative to using paper forms to fulfill filing requirements for applicable Connecticut and federal law and regulations.

Basic Information on Who Should Fill Out the Subscriber Agreement

- The “**Signatory Authority**” is an *individual* (usually a corporate officer) who is authorized to sign permit applications, permit modification requests, reports, and other documents on behalf of a permittee or “Regulated Person” per RCSA §§22a-430-3(b)(2)(A). This person must sign the Subscriber Agreement in Section D.
- **Who can be the Signatory Authority?** For a corporation: a **responsible corporate officer**. For the purposes of this section, a responsible corporate officer means: a president, secretary, treasurer, or vice-president of the corporation in charge of a principal business function, or any other person who performs similar policy- or decision-making functions for the corporation, or the manager of one or more manufacturing, production, or operating facilities employing more than 250 persons or having gross annual sales or expenditures exceeding twenty-five million dollars (in second quarter 1980 dollars), if authority to sign documents has been assigned or delegated to the manager in accordance with corporate procedures.
- The **Subscriber** is person who will electronically submit the data and sign the DMR’s. They must sign Section E.
- If the Signatory Authority person (named in Section D) will be signing and submitting DMR’s, then this individual must also sign Section E as a Subscriber.
- The Signatory Authority may duly authorize other individual(s) to sign and submit DMR’s. Such individual(s) must each sign a separate Section E as a Subscriber. (see RCSA §§22a-430-3(b)(2)(B)).
- Subscribers **are** required to be employees of the permittee. A contractor or consultant **cannot** be named as a *duly authorized representative* of the permittee, and so **cannot** be a Subscriber.
