The contract between **New Opportunities, Inc.** (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and approved the office of the Attorney General on 01/28/2014 is hereby further amended as follows:

1. Page 3. Part 1.B.3 Client Characteristics in the original contract shall be deleted in its entirety and replaced with the following:
 - 3. Client selection criteria:** The Contractor shall serve Clients who meet the following criteria:
 - a. Is an elderly individual aged sixty (60) or older, or resides in a household with at least one elderly individual;
 - b. The elderly individual/household has experienced at least one (1) trip and/or fall and remain at increased risk for trips and/or falls;
 - c. Currently are eligible for Utility funded Home Energy Solution-Income Eligible (HES-IE) and/or Department of Energy funded Weatherization Assistance Program (DOE-WAP) services and comply with all HES-IE and/or DOE-WAP eligibility requirements for both Clients and Dwelling Units;
 - d. Consent to all applicable evaluation criteria and follow-up as specified by the Department, New Opportunities, and its subcontractors.
2. The Agency address on Page 1 of the original contract shall be changed from 25 Sigourney Street, Hartford, CT 06106 to 55 Farmington Avenue, Hartford, CT 06105.

All terms and conditions of the original contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.




