The contract between **Opportunities Industrialization Center of New London County, Inc.** (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and approved by the Office of the Attorney General on 03/18/2014, is hereby further amended as follows:

1. The total maximum amount payable under this contract is decreased by \$25,000.00 from \$126,000.00 to \$101,000.00. This decrease is due to Contractor's underperformance.
2. The budget on page 12 of the original contract shall be deleted and replaced in its entirety by the budget on page 2 of this amendment.

All terms and conditions of the original contract, and any subsequent amendments thereto, which were not modified by this Amendment shall remain in full force and effect.
