The contract between Junta for Progressive Action, Inc. and the Department of Social Services, which was last executed by the parties and approved by the Office of the Attorney General on 3/9/2016, is hereby further amended as follows:

- 1. The total maximum amount payable under this contract is increased by \$65,21& from \$86,957 to \$152,175. These funds are to allow Contractor to continue the services for an additional nine months.
- 2. The budget on page 13 of the original contract is deleted and replaced in its entirety by the budget on page 2 of this amendment.
- 3. The term of the contract is extended for an additional nine months and the end date of the contract is changed from 9/30/16 to 6/30/17.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.
