The contract between Jewish Federation Association of Connecticut, Inc. ("Contractor") and the Connecticut Department of Social Services ("Department"), which was last executed by the parties and approved by the Office of the Attorney General on8/17/2015, and previously amended on 7/1/2016 is hereby further amended as follows:

- The term of the contract is extended for an additional one (1) year and the end date of the contract is changed from 6/30/17 to 6/30/18.
- The total maximum amount payable under this contract has increased by \$50,000 from \$100,000 to \$150,000. The funding will allow for the provision of citizenship training services to a minimum of 75 clients during SFY 18.
