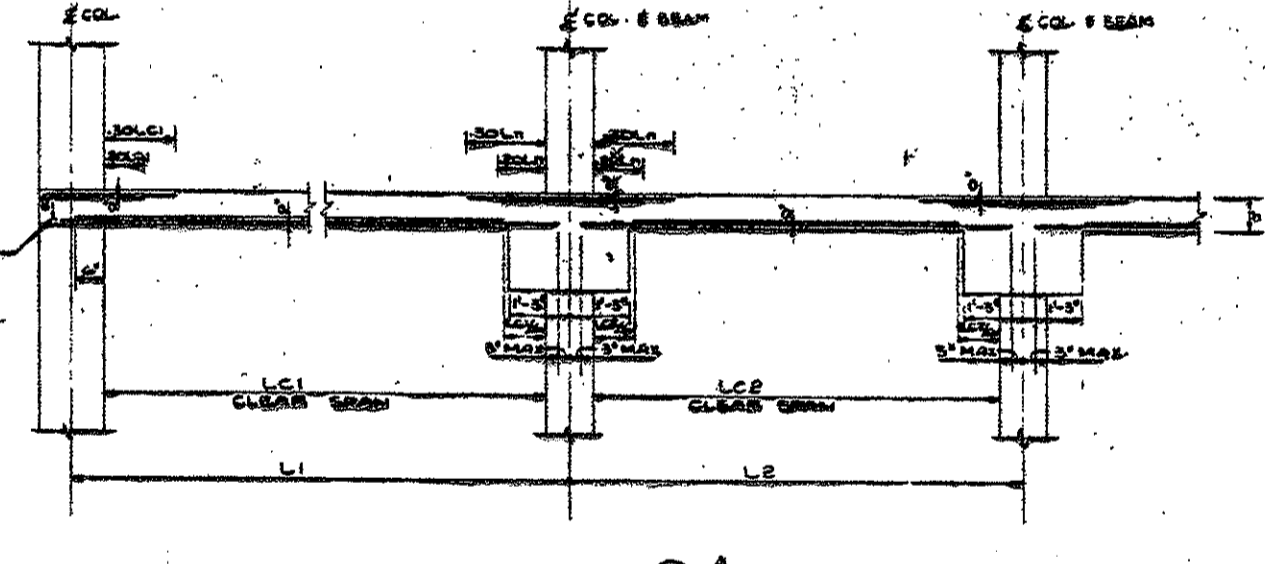


TYPICAL TENDON PROFILES

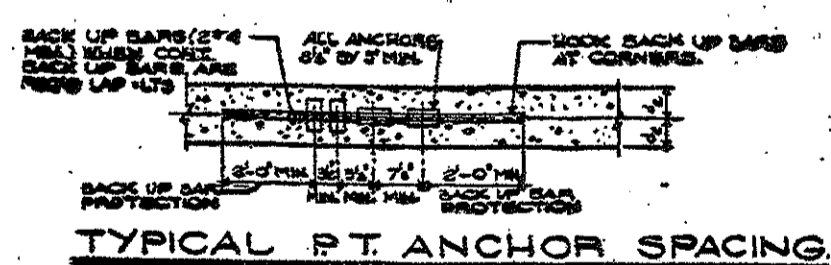

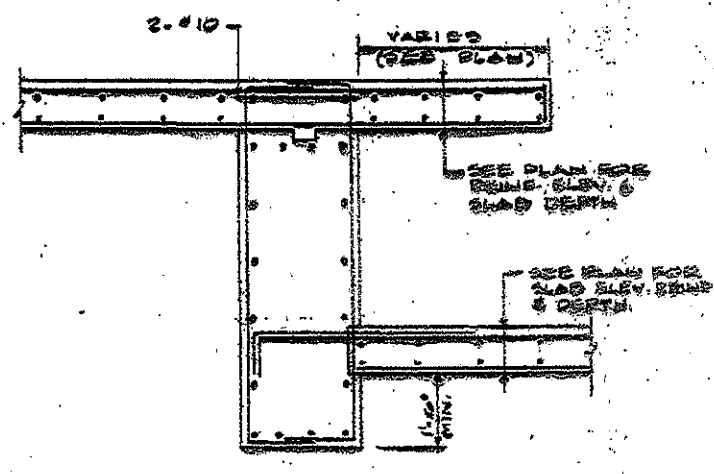
TYPICAL POST-TENSIONING SLAB DETAILS



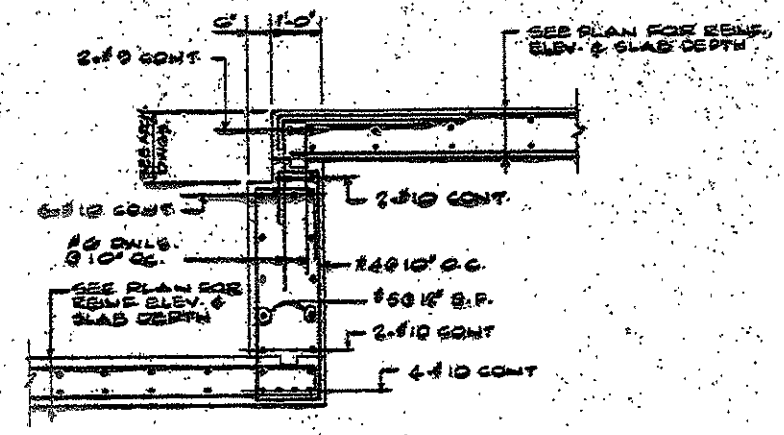

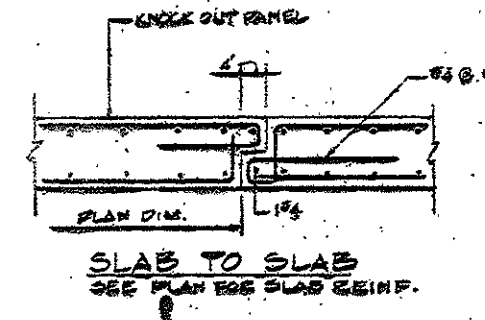
TYPICAL EMBEDDED ANCHOR FOR BRICK RELIEF ANGLE



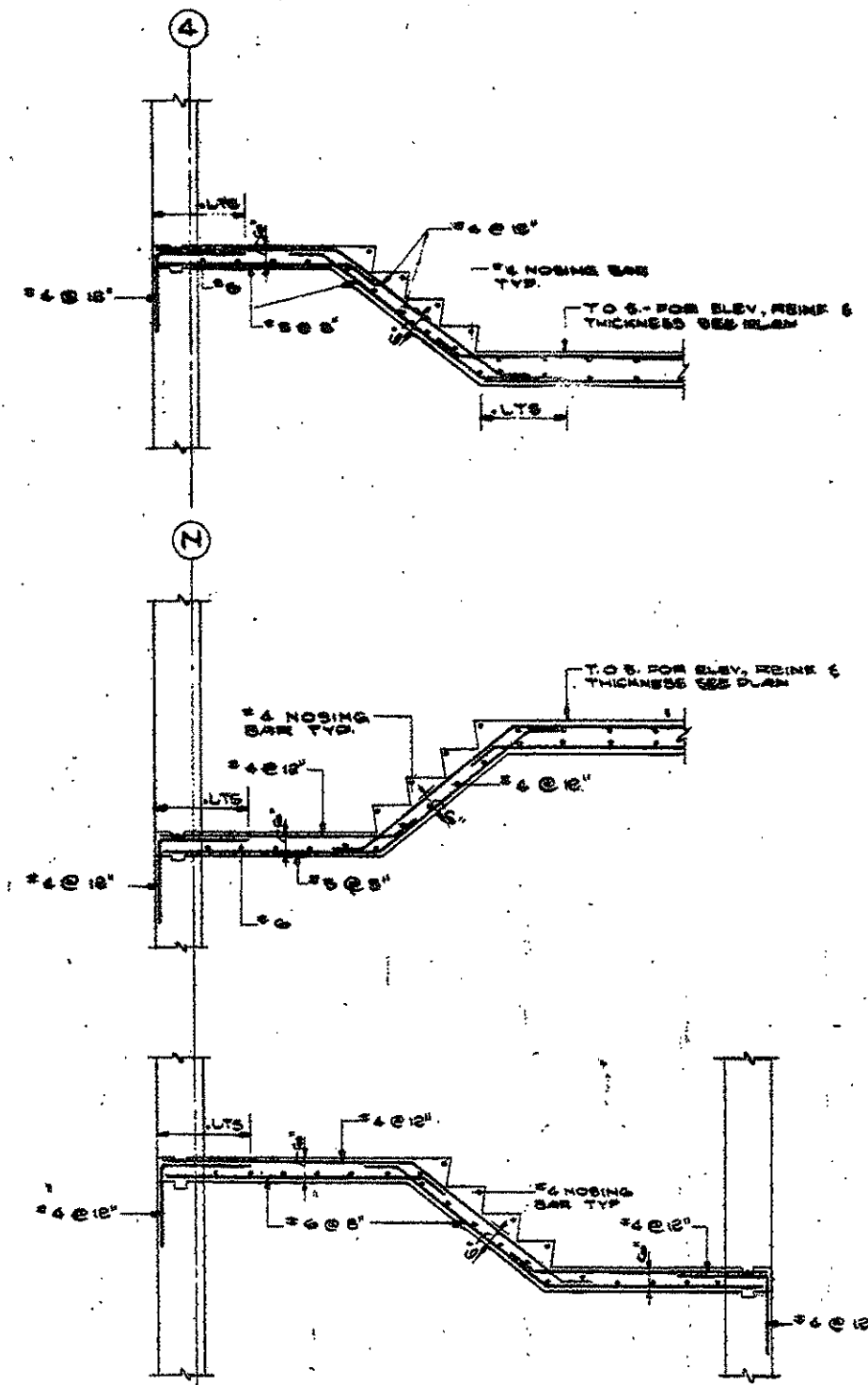
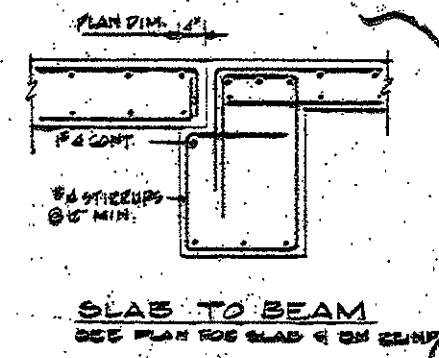

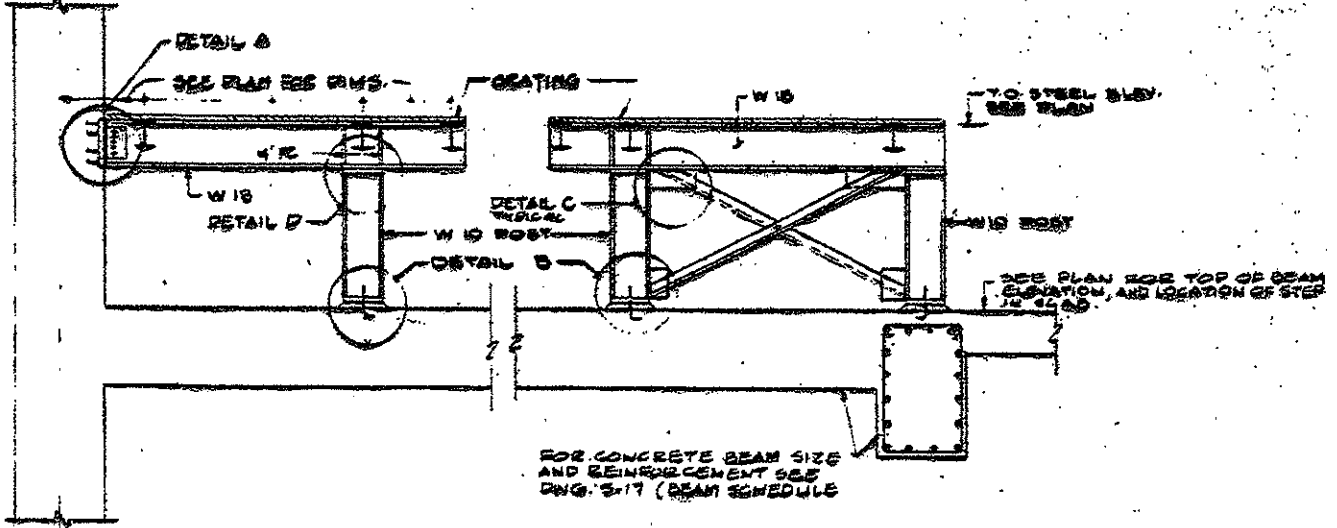
TYPICAL EMBEDDED RATE DETAIL FOR ELEVATOR SEPARATOR BM



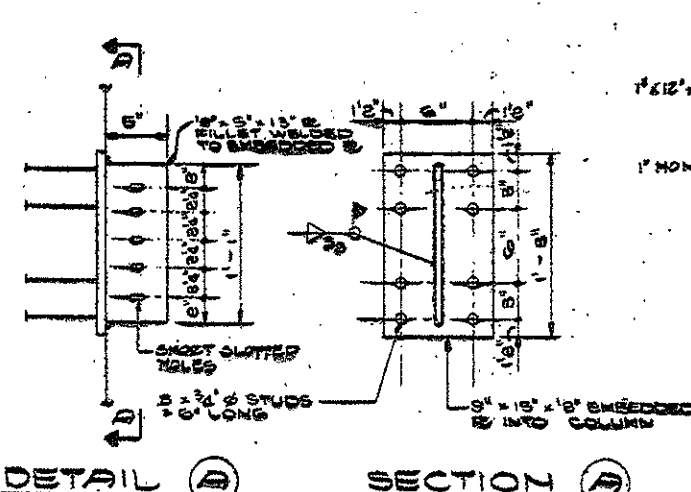

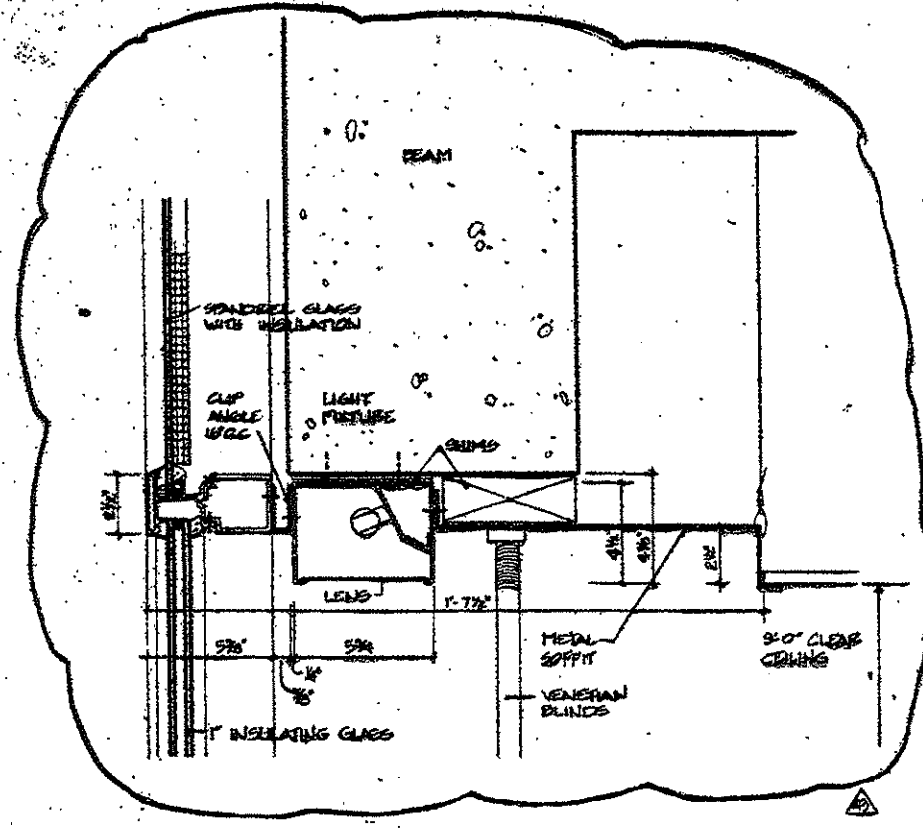


TYPICAL TOWER WINDOW JAMB DETAIL
