Who Must File

Each nonparticipating manufacturer selling cigarettes to consumers within Connecticut, whether directly or through a distributor, dealer, or similar intermediary or intermediaries, must establish a qualified escrow fund for the benefit of the State of Connecticut and other settling states, place the required amount of money into a qualified escrow fund, and file **Form TPM-1**, *Certification of Compliance and Affidavit by Nonparticipating Manufacturer*. For more information on completing this form, see **Announcement 2017(2)**, 2017 Revisions of Forms TPM-1 and TPM-2.

When and Where to File

No later than 30 days after the end of each quarter, the nonparticipating manufacturer must place the required amount of money into a qualified escrow fund and send Form TPM-1, signed before notaries
