# Schedule of Motor Vehicle Fuel Purchased in Connecticut for Export Instructions

You must report the following information:

- List the name of the Connecticut licensed distributor from whom the motor vehicle fuels was purchased;
- List the Federal Employer Identification Number (FEIN) of the Connecticut licensed distributor from whom the motor vehicle fuels was purchased;
- List the state to which the fuel was exported. A separate line entry should be listed for each state of destination; and
- List the total number of gallons exported to the state listed.
