We are writing to you on behalf of our client New Cingular Wireless PCS, LLC ("AT&T") with respect to the above referenced matter and our client's intent to file an application with the State of Connecticut Siting Council for approval a proposed wireless communications tower facility (the "Facility") within the Town of Norwalk.

State law requires that record owners of property abutting a parcel on which a facility is proposed be sent notice of an applicant's intent to file an application with the Siting Council. The Facility candidate is located on State property, an armory located at 284 New Canaan Avenue (Route 123), and is identified as parcel number 5-46-76 by the Town of Norwalk Tax Assessor. 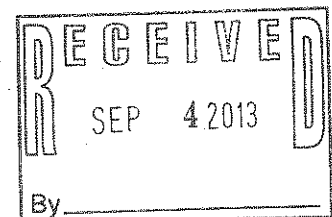

NOTICE

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Section 16-50l-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after September 3, 2013 by New Cingular Wireless PCS, LLC ("AT&T" or the "Applicant") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in Norwalk, Connecticut.

The proposed facility is located at the State Armory, 284 New Canaan Avenue (Route 123) which is identified as parcel number 5-46-76 by the Norwalk Tax Assessor. The proposed facility is located in the central portion of the 11.5 acre parcel and is proposed as two 140-foot self-supporting towers with internal antennas. The towers, antennas and ground equipment will be located within a 50' x 80' fenced equipment compound area. Vehicular access to the Facility would extend from New Canaan Avenue over the existing driveway and parking lot to the tower compound.

The location, height and other features of the proposed Facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

The Facility is being proposed to allow AT&T and other carriers to provide wireless services in this area of the State. The Application explains the need, purpose and benefits of the facility and also describes the environmental impacts of the proposed facility. The facility will be available for co-location by other wireless carriers.

A balloon, representative of the proposed height of the facility, will be flown at the proposed site on the first day of the Siting Council public hearing on the Application, which will take place locally, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.

Interested parties and residents of the Towns of Norwalk and New Canaan, Connecticut are invited to review the Application during normal business hours after September 3, 2013 at any of the following offices:
