JAG funds may be used to purchase equipment within the following federal program categories. (Grantees must report “quantity” and “expenditures” according to the sixteen categories). In order to receive grant reimbursement all towns must submit a complete grant application, and await budget approval.

VERY IMPORTANT: Equipment Purchases made PRIOR to the Award period “start” date are NOT eligible for grant reimbursement. The “start” date shall be clearly stated on the grant Award documents.

IMPORTANT: JAG funds can't pay for service, support or maintenance contracts that run beyond grant period. So, service, support & maintenance costs must be included in the equipment purchase price.

Vendor's invoice to town must have a separate "line item" for each piece of equipment.

Installation service may be invoiced as a separate line item or the installation costs may be included in the equipment purchase price.

Non-allowable use of funds:

Funds may **NOT** be used for personnel, over-time, straight-time, consultants, trainers, renovation, remodeling, construction, furniture, tables, chairs, office supplies, bullet-proof vests, uniforms, all-terrain vehicles, helicopters, boats, Segways, confidential "buy money", travel, food and beverage.
