#### National School Nurse Day! Wednesday, May 8, 2013

National School Nurse Day will be celebrated on Wednesday, May 8, 2013. This is a time to honor the more than 74,000 school nurses across the country, who make a difference in the lives of children and youth every day. This year, the National Association of School Nurses' (NASN) theme, *Advocacy, Access, Achievement: Leading the Way*, captures school nurses' significant role in improving students' health and academic outcomes.

According to the NASN, "we are in a unique position to promote prevention and wellness, providing access to care for our children and youth to stay healthy, safe and ready to learn. Research shows that early access to care and prevention strategies is vital, which is why school nurses promote healthy lifestyles and disease prevention for students during their early and most vulnerable years – and lasting through high school. School nurses are an invaluable bridge that connects health care providers, public health and families. Working with 98 percent of school-aged children in the United States, we are the daily eyes and ears of health care providers and public health, and serve our nation's most vulnerable children by addressing their health risks and helping parents navigate our complex health system."

#### **Did you know?**

**National School Nurse Day Background**: Since 1972, National School Nurse Day has been set aside to recognize school nurses.

**Purpose:** National School Nurse Day was established to foster a better understanding of the role of school nurses in the educational setting.

**Date**: National School Nurse Day is celebrated on the Wednesday within National Nurse Week and National Nurse Week is always May 6th through May 12th.

**Connecticut**: The CSDE's Health Promotion Services/School Nurse Program provides consultation to school nurses, school nurse leaders, school administrators and the community regarding the health and safety of students. This consultation and technical assistance includes addressing the provisions of health services during the school day and the promotion of health and wellness activities that support student achievement. Professional development programs are periodically organized to further assist and support school nurses.

#### **Pre-K Influenza Immunization Survey**

As of January 1, 2012, and each January 1st thereafter, influenza vaccine is required for all Pre-Kindergarten (Pre-K) students 24 through 59 months of age. In order to measure the effectiveness of this new requirement, the Connecticut Department of Public Health's (DPH) Immunization Program is asking all schools with local or regional board of education Pre-K programs to complete the Pre-K Influenza Immunization Survey. Pre-schools licensed by the DPH are surveyed separately.

Because the DPH is measuring compliancy with the influenza vaccination requirement deadline of January 1st, this survey only pertains to children who were enrolled in Pre-K as of January 1, 2013, and aged 24–59 months as of that date. Children enrolled between January 1, 2013, and March 31, 2013, should still be vaccinated to be compliant with the influenza requirement. The DPH is looking for the number of children who were vaccinated with at least one dose of influenza vaccine between July 1, 2012 and December 31, 2012, as well as any children with religious or medical exemptions. The information gathered from this survey and future surveys moving forward will help us track influenza coverage levels in these age cohorts as well as monitor the rate of flu exemptions.
