2009-10 School Health Services Information Survey

Thank you for your efforts last year with the School Health Services Information Survey. We received 66 percent of the surveys back from Connecticut school districts. A copy of the report along with the 2004-09 Summary Highlights Report are available from the EDUCATION CONNECTION Web site at http://www.educationconnection.org/new/programs/prog_sde.php or the Connecticut State Department of Education (CSDE) Web site at <http://www.sde.ct.gov/sde/cwp/view.asp?a=2678&q=320768> (scroll down to “Definition of School Nursing/Survey” section).

The CSDE would again like to request your participation in the School Health Services Information Survey. This survey represents an opportunity to continue documenting the school health services provided to students and staff in Connecticut public and private, non-profit schools. This survey was introduced in 2004 and has been revised slightly per your comments for this year's data collection. Data collection for the 2009-10 academic year should be conducted during February and March. All surveys **MUST** be completed by June 30, 2010, to allow adequate time for data analysis.

All information needed to complete the survey may be found on the EDUCATION CONNECTION Web site at www.educationconnection.org. On the homepage you will see a list of links. The first link in the list is entitled “Professional Development and School Improvement.” Please click that link. On the left side of the next page you will see a list of services provided. Follow the link to “Survey Services.” At the bottom of the next page you will see a section entitled “Current Surveys.” The survey listed is called the “SDE Health Services Survey.” Please click that link and enter the SDE School Health Services Web page.

On that Web page, you will see instructions to complete the survey, a sample form for data collection by school nurses at the building level, the 2010 School Health Services Information Survey, and reports from the last years of data collection including the summary reports tracking trends over time. A list of all school districts in Connecticut and their school codes is also posted for your convenience.

Each School Nurse Coordinator/Supervisor will need to gather some of the data from each building and compile the information. As the coordinator/supervisor, you will be entering only the totals for your district into the School Health Services Information Survey.

I would like to thank you in advance for your participation in this important project. This annual report will be distributed to each school district and will provide useful information from a state and regional perspective. Brain Injury Awareness Month - March 2010

This year, in recognition of Brain Injury Awareness Month, Centers for Disease Control and Prevention (CDC) encourages school professionals, coaches, parents, and athletes to learn the risks for concussions in youth sports. A concussion is a type of traumatic brain injury caused by a bump, blow, or jolt to the head.

An estimated 135,000 sports and recreation-related traumatic brain injuries, including concussions, are treated in United States emergency departments each year (1). Most persons with a concussion recover fully. However, returning to sports and other regular activities too quickly can prolong recovery time, sometimes for months. A repeat concussion that occurs before the brain recovers from the first can be very dangerous and might slow recovery or increase the chances for long-term problems.

To date, CDC has disseminated approximately 1.3 million educational pieces on concussion in sports for health-care professionals, coaches, parents, and athletes (2). CDC's next steps include an online training course for coaches on concussion prevention, recognition, and response. CDC also will be launching a national initiative that consists of educational materials for school professionals who work with students aged 5 through 18 years (or in Grades K-12). The new initiative, **Heads Up to Schools: Know Your Concussion ABCs**, will focus on the prevention, recognition, and response to concussion in schools. The Flu Season is Not Over Yet: Have you Been Vaccinated?

The flu season is not over yet. Seasonal flu usually peaks in February and March, and activity can be seen as late as May. According to the Centers for Disease Control and Prevention (CDC) "increased activity from either seasonal flu, 2009 HINI or both are still possible this season." The CDC cites the 1957-58 pandemic where flu activity dropped in December and January and assuming the worst was over, they stopped encouraging people to get vaccinated, only to have flu activity increase abruptly in February and March, and hospitalizations and deaths increased as well.

The CDC's updated **Technical Report for State and Local Public Health Officials and School Administrators on CDC Guidance for School (K-12) Responses to Influenza during the 2009-2010 School Year** encourages vaccination for all students and staff who are recommended for vaccination. Remember that vaccination not only protects you, but also protects the children and staff in our schools. As school nurses, we work with two of the priority, high risk populations associated with HINI influenza: young children/young adults and pregnant women.

GENERAL STATEMENT OF DUTIES:

To assist in the development and improvement of services and programs for children in the Child Nutrition Programs (CNP).

EXAMPLE OF DUTIES:

Duties may include the following administrative, consultative, and advisory activities:

- monitor and evaluate programs with the CNP unit;
- provide oversight and monitoring of the Fresh Fruit and Vegetable Program;
- assist with the implementation of the Child and Adult Care Food Program (CACFP) Supper Program and other CACFP programs;
- assist with the development and submission of annual reports related to state and federal regulations; and
- perform related duties as required.

QUALIFICATIONS:

Knowledge, Skill and Ability:

A thorough knowledge of federal laws and regulations pertaining to the Child Nutrition Programs; knowledge of the philosophy and methods of education with particular reference to the field of nutrition, institutional management and child development.

Minimum Experience and Training Required:

A Master's degree and one (1) year of professional experience, or in lieu thereof, an equivalent combination of experience and training as approved by the appointing authority.

Preferred Experience and Training:

A registered dietician is preferred; however, the Department encourages applicants who do not meet the stated qualifications but who believe they possess equivalent qualifications to submit, in addition to their resumes, written statements indicating how their background and experience qualify them for the position.

National Poison Prevention Week

The Connecticut Poison Control Center (CPCC), a free and confidential service of the University of Connecticut Health Center is available 24/7 to answer your poison exposure and information calls throughout the state. What awaits you at the other end of the telephone line? Over 200 years of experience and expert toxicology advice from specialists in poison information who are registered nurses, doctors and pharmacists. What do school nurses like best about our service? When the case warrants it, the specialist in poison information calls back to check on the patient and follow-up. Nurses love that!

Calls from Connecticut schools vary, but many fall into the following categories: art supplies, chemicals, cosmetics, heavy metals (for example, elemental mercury from thermometers used in science classrooms), plants, eye exposures and poisons used in pranks and dares (fire extinguishers, stink bombs and pepper spray). Children get exposed to poisons by ingestion, inhalation, absorption through the skin and ocular exposure.

The CPCC point of service displays were sent to all elementary, middle and high schools in 2008. Results indicate a 97 percent satisfaction rate from school nurses and school nurse supervisors. The educator has fulfilled a number of school nurse in-services statewide: 260 attendees at seven events that included local, regional and statewide reach. Content includes: beyond the basics; school exposure data, trends, and common calls; communication; CPCC education resources; and CPCC marketing research findings.
