



# **Annual Report on the Use of Physical Restraint and Seclusion in Connecticut**

*School Year 2011-12*

## Background and Overview

Public Act 12-88 requires the Connecticut State Department of Education (CSDE) to produce an annual summary report to the Connecticut General Assembly that:

- identifies the frequency of use of physical restraint and/or seclusion (R/S); and
- specifies whether the use of such seclusion was in accordance with an individualized education program (IEP) or whether the use of physical restraint or seclusion was an emergency.

Additionally, the Act requires the CSDE to report on R/S incidents that result in physical injury to the student.

Data regarding restraints and seclusions for 2011-12 were collected from:

- 169 local education agencies (LEAs) including regional school districts, the Department of Mental Health and Addiction Services (DMHAS), Unified School District (USD) #2 and the Connecticut Technical High School System (CTHSS);
- three endowed and incorporated academies (Academies);
- 17 public charter schools;
- six regional education service centers (RESCs); and
- 58 approved private special education programs (APSEPs).

R/S incidents were reported for two types of students: students with an IEP *and* students for whom parental consent to evaluate for special education had been obtained. General Education students were not reported in these data, unless they were in the evaluation process for special education services at the time of the restraint or seclusion.

## Definitions and Concepts

### Major Categories of R/S

1. **Emergency Restraint** means any mechanical or personal restriction that immobilizes or reduces the free movement of a child's arms, legs or head.

Restraint does *not* include:

- briefly holding a child in order to calm or comfort the child;
- actions involving the minimum contact necessary to safely escort a child from one area to another;
- medication devices, including supports prescribed by a health care provider to achieve proper body position or balance;
- helmets or other protective gear used to protect a child from injuries due to a fall; or
- helmets, mitts and similar devices used to prevent self injury when the device is part of a documented treatment plan or IEP and is the least restrictive means to prevent self-injury.

2. **Emergency Seclusion** means the confinement of a child in a room, whether alone or with staff supervision, in a manner that prevents the child from leaving.

Seclusion does *not* include:

- time outs in the back of the classroom or in the hallway, meant to give the student a minute to pull themselves together; or
- in-school suspensions.

3. **Seclusion via an IEP** means seclusion as a behavior intervention that is documented in the IEP. Seclusion is a strategy that can be developed by the Planning and Placement Team (PPT) to address a child's behavior which may interfere with the child's learning or the learning of others, if other less restrictive, positive behavior interventions appropriate to the behavior exhibited by the child were tried but the child's behavior did not improve. Appropriate assessment data and other relevant information used by the PPT in deciding to use seclusion as a behavior intervention must be included in the child's IEP under "Present Levels of Academic Achievement and Functional Performance."

### *Subcategories of Injuries*

1. **Nonserious Injuries** include red marks, bruises or scrapes that require a Band-Aid or application of basic first aid.
2. **Serious Injuries** include any injury requiring medical attention beyond basic first aid.

## **Methodology**

Instances of R/S for school year 2011-12 were collected in the aggregate from all institutions and facilities (henceforth referred to as "districts") that provide direct care, education or supervision to students. Districts were asked to report all restraints and seclusions that occurred within their buildings and programs or during transportation provided by their district. Additionally, districts were instructed to include any restraints or seclusions of their students that occurred in out-of-state facilities, nonpublic transition programs, and other nonpublic schools or during an extended day program offered by their district. LEAs were specifically instructed not to report instances of restraint and seclusion of their students at RESCs, charter schools, academies, or APSEPs because each of those facilities was responsible for separately reporting their R/S data.

Upon receipt of data from all districts, edit checks were applied to ensure data integrity. All instances where data quality indicated concern were reviewed with the district contact person. Additionally, comparison reports were sent to all districts where data reported for 2011-12 indicated a significant departure from those in 2009-10. In some cases, data reporting errors were discovered for one or both years of reporting. All errors identified for 2011-12 were corrected in the database. Additionally, districts whose data were accurately reported as varying across reporting years provided written feedback explaining the factors contributing to the data shift. Finally, all districts were required to submit a Restraint and Seclusion Certification Document signed by the superintendent or designee. Each of these attestations regarding the accuracy of 2011-12 R/S data reported is on file with the CSDE.

## Results

Table 1 presents all **incidents** of R/S that occurred during the 2011-12 school year where physical restraint or seclusion was used as an emergency response. It is important to note that these data do *not* represent an unduplicated number of students. Emergency R/S data reported for the 2011-12 school year are comparable to the 2009-10 school year. A total of 18,334 incidents statewide were reported in 2009-10 as compared to 18,916 in 2011-12.

Table 2 presents all **incidents** of seclusion, via an IEP, that occurred during the 2011-12 school year. It is important to note that these data do *not* represent an unduplicated number of students. In 2009-10, districts were instructed not to include seclusions via an IEP, therefore no comparable year data are available.

In total, eight serious injuries of students were reported for the 2011-12 school year; six occurred during an emergency restraint and two during seclusion via an IEP. All eight incidents in 2011-12 that resulted in serious injury were reported to the director of the Office of Protection and Advocacy for Persons with Disabilities. District-level data for all incidents of R/S that occurred during the 2011-12 school year are presented in Appendix A. Data for the 2009-10 school year are presented in Appendix B.

## Limitations to Data Interpretation

During the year-to-year comparison data cleaning conducted by the CSDE, districts were asked to provide written feedback explaining any factors that may account for data changes or provide context for data interpretation. All responses received by the CSDE were reviewed and several trends were noted across districts. It is critical to consider these important caveats when reviewing the aggregate data for the purpose of drawing conclusions or making recommendations. Academy data will not be discussed here as the numbers are zero and do not necessitate explanation. APSEP data will not be discussed here as there is no comparison data from a previous year from which to draw conclusions. The comments below reflect information obtained from LEAs and RESCs; some of the responses addressed data accuracy and others addressed changes in practice.

### *Reasons for District Reduction in Reported R/S Incidents*

- (1) In 2009-10, when the CSDE collected R/S incident data for the first time, many districts were unable to distinguish in their compilation the differences between a) seclusion via an IEP and an Emergency Seclusion and b) seclusion and a “time out”. The districts choose to report all incidents, regardless of type, in that year. Districts have since updated their compilations to distinguish these differences.
- (2) Many incidents of R/S reported in previous years were for students with significant self-injurious and aggressive behaviors. These students each had multiple incidents. PPT decisions have resulted in these students being placed in more restrictive settings outside the LEA to better accommodate their specific behavioral and educational needs.
- (3) New district procedures for documenting and reporting R/S incidents have been implemented to improve the accuracy of the district R/S compilation. District staff members have been trained in the new procedures to improve the validity and reliability of the data.
- (4) Districts have adopted new de-escalation procedures and trained all staff using the applicable professional development options including but not limited to: Crisis Intervention Process; Physical and Psychological Management Training; Strengths-Based Approaches to De-Escalation; and the use of Board Certified Behavior Analysts to design student-specific targeted interventions. Many districts have attested to the change in district policy and procedures regarding de-escalation of aggressive student behaviors as the reason for significant reductions in the use of R/S.
- (5) Several districts have reported that students with multiple incidents in the 2009-10 school year have since adapted to the program expectations and are having success with the

behavior management plans that districts have in place. Therefore, these students are less likely to engage in behaviors that would result in the need to use R/S by staff. These success stories are the reason district incidents are down in current data.

#### *Reasons for Increases in Reported R/S Incidents*

- (1) In 2009-10, when the CSDE collected R/S incident data for the first time, districts were instructed not to include reports of seclusion via an IEP in their compilation. In many districts, the reporting of seclusion via an IEP has greatly increased the number of reported incidents.
- (2) Districts saw dramatic increases in their reported R/S incidents due to one or a handful of students with significant self-injurious and aggressive behaviors. These students had multiple incidents each. For example, in one public school district, 150 of 155 reported restraints were for one student. At the time, this student was engaging in self-injurious behavior and restraint was used to protect the student from self injury. A large number of districts reported a similar type of explanation for significant increases in incidents. In fact, Highville Charter School reported a total of 14 seclusions, the largest for all charter schools. These 14 incidents represent only one student in the school.
- (3) Many LEAs reported that by increasing the available programming options within their public schools, they were able to decrease the number of students outplaced. These programming changes resulted in more students with “acting out” or other significant behavior issues remaining in the district. Any R/S incidents for these students in prior years would have been reported at the APSEP or RESC location where the student was previously served.
- (4) A few districts reported that they have designed specialized in-district programs to serve students with significant needs and have accepted many tuitioned students from other districts. Two RESCs reported that the enrollment in their programs has doubled over the last three years, resulting in twice as many students contributing to the reported incidents. Again, in prior years these students would have been reported by the sending district, APSEP or RESC location where they were previously served.
- (5) Several districts reported that in 2009, they were not maintaining the required annual compilation of R/S incidents. In those districts, increases were due to the fact that the district is now in compliance with state law.
- (6) Some of the discrepancy seen across districts also relates to how each district counts multiple events in a sequence. For example, a student demonstrates a behavior that results in a 5 minute restraint; as the staff member begins to release the student, the student immediately resumes the prior aggressive behavior and is restrained once again by staff. Under R/S reporting guidance, each restraint/release should be considered one incident. In follow-up with districts, it became clear that some districts had not been filling out their R/S incident reports using this guidance. Therefore districts following the reporting rules would appear to have dramatically more incidents of R/S as compared to a district that reported all restraints/releases within a given time period as one incident.

## **Moving Forward**

For the 2011-12 school year, all R/S incidents were reported in the aggregate. Starting with the 2012-13 school year, this collection will include data at the individual child *and* incident level. This will provide not only a count of incidents but also an unduplicated count of students who are subject to restraints and seclusions. Incident level data alone is insufficient to draw any meaningful conclusions about the use of R/S in Connecticut schools. Collecting both child *and* incident level data is vital to getting an accurate picture of the prevalence of R/S among Connecticut's student population. This breakout will also allow for a critical examination of the use of emergency restraint and seclusion and seclusion as a behavior intervention strategy.
