**FINAL DECISION AND ORDER**

**ISSUES:**

Did the Board offer an appropriate program for Student in the 2015-2016 school year?

**PROCEDURAL HISTORY/SUMMARY:**


The Parent filed the Due Process Complaint and Request for Hearing on October 27, 2015. The Hearing Officer was appointed on November 3, 2015 and scheduled a prehearing conference for November 19, 2015. On November 16, 2015, the Parents sent a letter to the Hearing Officer stating that the parties had settled their dispute at a Resolution session and that the Parent was withdrawing the Due Process Complaint.

**FINAL DECISION AND ORDER:**

The matter is **DISMISSED**.

If the local or regional board of education or the unified school district responsible for providing special education for the student requiring special education does not take action on the findings or prescription of the hearing officer within fifteen days after receipt thereof, the State Board of Education shall take appropriate action to enforce the findings or prescription of the hearing officer.

Appeals from the hearing decision of the hearing officer may be made to state or federal court by either party in accordance with the provisions of Section 4-183, Connecticut General Statutes, and Title 20, United States Code 1415(i)(2)(A).
