MANDATORY OFFICIAL FILING: Head Moderator must make a duplicate set of returns and sign both sets; Head Moderator must seal and deliver one complete signed set of these returns immediately by hand to the Town Clerk. Head Moderator can send a complete signed set of returns by mail to the Office of the Secretary of the State, Elections Services Division, 2nd Floor, 30 Trinity St., Hartford, CT 06106 to be received no later than three days after the election. If late, the Head Moderator must pay a late fee of \$50.00.
