Box 150470, Hartford, CT 06115-0470 not later than 6:00 p.m. of the day after the election, or to the State Police not later than 4:00 p.m. of the day after the election and to deliver the other set to the Town Clerk. 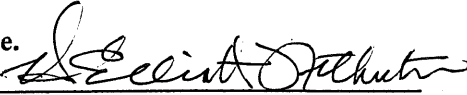
