The Head Moderator shall complete, sign, seal and deliver one set of such returns electronically to the Secretary of the State not later than forty-eight hours after the close of the polls and then deliver one such original return to the Secretary of the State not later than the third day after the election and deliver the other set to the Town Clerk. 
