After all entries have been completed and proofread and any corrections made, the complete set of returns should be photocopied and both sets signed in the original by the Head Moderator at each place indicated. The Head Moderator shall complete, sign, seal and deliver **one set** of such returns electronically to the Secretary of the State not later than **forty-eight hours** after the close of the polls and then deliver **one such original** return to the Secretary of the State **not later than the third day after the election** and deliver the other set to the Town Clerk.
