The Head Moderator shall complete, sign, seal and deliver <u>one set</u> of such returns electronically to the Secretary of the State not later than <u>forty-eight hours</u> after the close of the polls and then deliver <u>one such original</u> return to the Secretary of the State <u>not later than the third day after the election</u> and deliver the other set to the Town Clerk. Use additional pages, if necessary.
