Box 150470, Hartford, CT 06115-0470 not later than 6:00 p.m. of the day after the election**, or to the **State Police not later than 4:00 p.m. of the day after the election** and to deliver the **other set to the Town Clerk**. 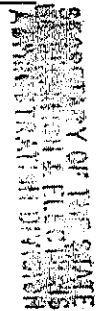
