Greetings:

2. Your Certificate of Ballot Order and Polling Place Report detailing addresses and Moderator names and addresses was due on Friday October 3. Please send or email the forms to us soon as you can. I have attached the forms for your convenience. It would be helpful to add your EDR location to that form as well if you have not already filed it with our office.
3. Reminder that even though we have Election Day Registration, you must hold a Special Voter Registration Session on Saturday October 18 from 10:00 am to 2:00 pm. In addition, you should be aware that the ERIC post card solicitation has resulted in thousands of new voter applications (over 6,000) in less than ten days. Registering new voters ahead of election day will contribute to your success in administering the new law allowing EDR and make first-time voting faster and more convenient for individuals who register ahead of election day. If people register ahead of election day it reduces potential problems, shortens lines, and reduces confusion on the day of the election.
4. As we noted in our conference call on September 17, the name and address on the post card was obtained from DMV records, not voter registration records. Therefore, if you receive any phone calls from the public, it may be that their name and/or address or d/o/b on their license is slightly different than their voter record. This is a good opportunity for you to check your records to see if the entry you have for the voter is correct. Voters are calling our offices as well, and we are discovering that the license might have the last name spelled as Keiser, for example, but the voter registry list spelled it as Keizer.
5. Reminder that the supply of Overseas Ballots we sent to you (ballots with only federal office) are also used as Provisional Ballots at the polls. Please be sure you send a sufficient supply of those ballots to the polls.

6. We continue to receive candidate withdrawals and replacements. As a reminder, state statute provides that as long as a candidate withdraws by 24 days prior to the election (October 10, 2014) they can be replaced by 21 days prior to the election (October 14, 2014). We make every effort to keep both LHS and Adkins aware of any changes on your behalf.
7. You will receive a Head Moderator's Return from our office in the coming days.
8. We have our first in a series of Conference Calls – Training and Preparation for Election Day 2014 - on Tuesday October 14, at 2 pm.
