Hot Topic: Add Alt description to images for Accessibility Compliance

Alternate text on an image provides a brief, meaningful description of the image that screen readers and search engines read to better understand the image.

Sitecore makes it easy to <u>include alternative text to any images</u>, <u>graphs or diagrams</u> you upload into the system. Sitecore will also give you a warning, alerting you when alt text is missing and needed.

Feature: Publish Content vs. By-Pass Approval

For System Administrators, there are usually two different methods to Publish items. Which one you use will depend upon the item you are publishing and if it has a workflow or not. Here is some guidance to help clarify the difference and which Publish method to use.

NOTE: Some Agencies have specific publishing methods just for their website, and this information may not pertain to them. Please consult with your Sitecore System Administrator with questions or clarification.

Publish Content Method

- Use this method for publishing additions, changes, and deletions to folders, navigation items, homepage sections, images, and document files.
- Pages that do not contain a workflow.

By-Pass Approval Method

Almost every page is assigned a workflow so Content Authors can Submit them and Content Approvers can review them before approving. **System Administrators** can by-pass this approval process and publish the item without approval with the By-Pass Approval function.

Use this method for publishing pages that are assigned a Workflow.

Support: Frequently Asked Questions

My password is not changing when I attempt to change it?
 You can change your password through the "Forgot Password" link on the <u>Sitecore Login Page</u> or directly through https://egov.ct.gov/UserMgmt/Login.aspx?Display=ForgotPassword.

- When setting a new password, make sure to follow the password policy closely.
- You cannot re-use any previous passwords.
- If logging in for the first time by copying/pasting your temporary password from our email, make sure to remove any extra spaces.
- See step-by-step instructions on changing your password.

Just as a reminder, passwords expire every 90 days and can be reset through the link in the password expiration alert emails you begin to receive 14 days prior expiration date.

- My images I inserted on the page are not the same as what's displaying on the website. Why?
 Multiple image files with the same file name in the same Media Library Folder will certainly create issues. Sitecore will associate files as the same when the files live in the same folder and subfolder with the same file name.
 - o capitalization does not make a difference (AgencyName SmLogo, agencyname smlogo)
 - o spaces or dashes do not make a difference (Agency Name smlogo, Agency-Name-smlogo)
- How do I Unlock (Check In) all my pages?
