The female caller came out of a door on the left front corner of the house. She was visibly upset and told me her upstairs neighbor was trying to get into her apartment through a common hallway that is located inside the multi-family house. I asked the woman if we could access this common hallway from her apartment, and she told me she had a large German shepherd in her apartment. I asked her to put the dog in her bathroom, and I was going to check on Officer Fournier. I walked around to the back of the house. The back of the house is split into two levels, with an entrance to the female caller's apartment on the first floor, and an entrance to the second-floor apartment up a short stairway, off a covered deck.
