


## **CT DCJ Fact Sheet:** The Windham Judicial District

The Windham Judicial District (JD) serves 15 towns in the northeastern part of the state. The local GA court (GA-11) is located in the Danielson section of the town of Killingly. Windham, the largest town in the District, contains Willimantic, an older urban center with approximately 17,100 residents.

About 117,000 people live in towns within the Windham JD, making it the smallest District in the state by population. Covering just over 512 square miles, the Windham Judicial district has the second lowest population density among JDs, after the Litchfield JD.



Ranked by per capita income, Windham JD towns are among the poorest in the state.

Pomfret, the most affluent town in the JD has an estimated per capita income of \$41,442. This compares with the statewide figure of \$43,056.

Eight towns in the District had per capita incomes lower than \$35,000. The town of Windham had the lowest per capital income in the state - \$20,064 - edging out the city of Hartford. Windham's low ranking was due in large part to Willimantic, where per capita income was estimated at \$17,294.

Only 15% of the District residents identify as members of minority communities. Hispanics are the largest minority group the District. They comprise 70% of the minority population. The Windham Judicial District MA

Each year, the FBI releases its Uniform Crime Report (UCR) which details the number of major crimes reported by state and local jurisdictions in the previous calendar year. In the UCR report, violent crimes includes murder, nonnegligent manslaughter, robbery, aggravated assault and rape. Property crimes include larcenies, burglaries and motor vehicle theft.

According to 2018 UCR data, towns in the Windham

JD experienced relatively low rates of violent and property crime.

the impact of the Covid pandemic.

Many towns in the Windham JD are too small to sustain a municipal police force. As a result, the State Police play a large, public safety role in the District. Only one town, Plainfield, has a fully independent police department. Putnam and Windham, maintain their own police patrols in only parts of the town with the State Police patrolling the remainder. All other towns in the District rely, solely, on State Troopers for their public safety needs. In terms of criminal arrests the Willimantic police, in Windham, were the most active police agency in the District.

The town of Windham falls within the jurisdiction of State Police Troop K. It is estimated that Troop K makes several hundred arrests each year that are handled by the Windham JD.

The bulk of criminal cases in the Windham JD are handled at the GA-11 in Danielson. The number of cases added each year has dropped consistently over the past five years. Between 2016 and 2019, the number of new cases

has declined by almost 20%.

Most serious cases in the district are generally transferred to the Part A Court. These cases are usually more complex, require deeper investigation and are more likely to go to trial.

In fiscal year 2019, the Part A court in Windham disposed 50 cases. The vast majority of these cases were disposed without trial. Statewide, fewer than 4% of Part A cases are disposed at trial.

Although no level of crime is acceptable, the towns in the Windham JD are fortunate to experience crime rates that are considerably lower than the state average.
