STATEMENT REPORT - Civilian Witness #8 05/22/2017 1652 - 1727 hours

ACTION TAKEN:

On the above date and time, I obtained a sworn, written statement from [redacted] at Troop G. [redacted] works for [redacted] and was working at [redacted] West Avenue, Bridgeport, CT during the officer involved shooting incident that occurred on 05/09/2017. That address ([redacted] West Ave.) is located between the cross streets Washington Avenue and Fairfield Avenue. The building at [redacted] West Avenue has an unobstructed view of the area of Fairfield Avenue where the officer involved shooting occurred. [redacted] was given videos and images captured by other workers at [redacted] West Avenue and expressed to Det. Kimball #877 that he would voluntarily provide the media. Upon seizing the media from [redacted] cell phone at Troop G, I obtained a written statement from [redacted]. The statement provided, in summary:

On 05/09/17, [redacted] was working at [redacted] West Ave, Bridgeport, CT. At approximately 5:20pm, he was on the fifth floor of that building looking down at an active Bridgeport Police scene on Fairfield Avenue. He learned shortly afterwards that the scene was related to an officer involved shooting, in which the involved officer was his [redacted]. Upon learning that his [redacted] was involved, [redacted] asked a couple individuals who he knew to have recorded video with their cell phones from the fifth floor to send him the
