When I arrived at his mother's house, I saw cop cars parked near the house. I saw his mom, sister, and Tony standing outside of the house. All three were crying and screaming. Jay was on the phone with us so I told him this was no joke and this was not the time to mess around. I told Jay the cops were outside his house. Jay said he's, "not going back" and, "the cops are going to be the ones to shoot me". Jay said these statements repeatedly. I told Jay he was young and that he could get through this and that he should just comply. I told Jay that it would only be a couple of years and that he can get through it. I told Tony, Carla and I had Jay on the phone. Tony then ran over to one of the cops at the scene and told him that I had Jay on the phone. The cops then had us drive to Nathan Hale School. We all crammed into my wife's Subaru and we went to Nathan Hale school. Another female cop took Carla into her patrol car to talk with Jay. Jay's family was going crazy and saying, "there is no need for this", and, "he's just a boy". I heard and watched the SWAT team getting ready to go to Jay's mom's house. I asked his family to relax and pray and ensured them this is what the police have to do to respond to the incident. We all left after some time and went to the Manchester Police Department.
