Passenger: Upstairs?

Oh, no. She says it's staying in me.

(Passenger is telling detectives that hospital staff has told him the round in his arm will be staying in him and will not be immediately removed via surgery.)

Allegro: Well...they may not operate on that now. They may wait a little bit. It's kinda like

a splinter. Sometimes, if you think of it that way, your body's ... it's a foreign

object. So it's eventually going to move it to the surface. So it might be in a
