Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary settlement amount of \$2,500. Respondent shall follow relevant statutes/regulations.

For some of the closures, the Commission of Pharmacy was not timely notified. Due to some early closures, the Pharmacy operated below 35 hours of operation. Additionally, there was a period with no active pharmacy manager and a related failure to timely notify the Commission of Pharmacy.

Proposed Resolution:

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary settlement amount of \$3,000. Respondent shall follow relevant statutes/regulations.
