### **Legal Matters**

Case Number: 2022-1377 **Procare**; **PCY.0002214** Attorney Michael Ando presented this case.

Respondent is a Connecticut Pharmacy investigated for distribution of controlled substances to an individual with an inactive federal registry number, on the basis of information obtained in a separate investigation. Additional violations were alleged including record keeping violations. Respondent immediately and voluntarily instituted substantive changes to address all allegations. Both the investigation and resolution involve parallel activity at the federal level.

## **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$30,000, which has been paid. The agreement recognizes significant voluntary corrective actions taken by the Respondent, which Respondent shall maintain through updated processes.

**Commission Action:** Commissioner Inguanti moved, seconded by Commissioner Taylor and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Case Number: 2022-19033 **Ryan Christopher Bango; PCT.0010221** Attorney Michael Ando presented this case.

Respondent is a Connecticut Pharmacist investigated following an error complaint. This is the second error in a three year period, however Respondent has an error history. Commissioner Linder stepped down in a Compliance Meeting with Respondent.

## **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall be placed on a one year probationary status in which Respondent acknowledges that subsequent errors in such period may result in the reopening of the instant case and additional discipline. Respondent shall pay a voluntary monetary payment amount of \$2,000, which has been paid. Additionally, within 60 days Respondent shall complete online continuing education courses related to Medical Safety/Reconciliation, and Medical Errors. These hours will not be credited to the Respondent for his annual requirement.

### 'First Time' Pharmacy Manager (s)

The following pharmacists presented themselves to the Commission of Pharmacy as 'first time' pharmacy managers in the State of Connecticut: Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Some responsibilities include leadership, technician registration, license renewals, reporting pharmacy operation hours, and prescription error reporting.
