Legal Matters

Case Number 2021-1684 **Mark Sampieri**

Attorney Katrina Cessno presented this case. Commissioner Cafferelli 'stepped down'. This case involved Prospective Licensee is a former Connecticut Pharmacist who voluntarily surrendered his license in 2021 following an investigation for restocking non-controlled medications that were returned to the pharmacy and were put on the shelf to be reused. Licensee has requested reinstatement of his pharmacy license and has agreed to the following proposed resolution.

Proposed Resolution:

Counsel for the Drug Control Division proposes an agreement in which prospective licensee shall be licensed as a Connecticut Pharmacist, but shall be subject to a twelve month probationary period during which he will neither work as a pharmacy manager nor serve as a preceptor or trainer for any pharmacy interns. During this period he shall also complete a designated pharmacy manager continuing education course and shall obey all state and federal laws and regulations related to pharmacy practice. He will also receive a letter of reprimand.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Carbray and passed by a vote of 4-0 to accept and approve the aforementioned settlement agreement.

Jeff Lagasse, Pharmacy Manager is requesting pharmacy to be open less than 35 hours a week.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Inguanti and passed by a vote of 5-0 to grant the request coterminous with the Governor's Executive Order 71 emergency plan extended until February 15, 2022. If there is no extension to the order pharmacy hours will revert back to 35 hours minimum a week.

Nancy Babbar is requesting to waive 2020 and 2021 CE Credit requirements.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner In and passed by a vote of 5-0 to grant the license renewal and waive the Live CE Credits. Contingent on completing the CE credits for a total of 30 to be in compliance for 2020 and 2021, this needs to be verified by the board of pharmacy and completed by May 25, 2022. If the requirement is not met the license will be revoked by June 1, 2022.

Jill Strykowski is asking for an extension to complete her CE credits 2020 and 2021.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Cafferelli and passed by a vote of 5-0 to grant the extension and waive the Live CE Credits. Contingent on completing the CE credits for a total of 30 to be in compliance for 2020 and 2021, this needs to be verified by the board of pharmacy and completed by May 25, 2022. If the requirement is not met the license will be revoked by June 1, 2022.
