The Board voted to deny Mr. Gemma's application due to insufficient documentation of equivalent experience and training. The Board noted that the out of state licenses held do not equate to the scope of work of the S-2 license type.

The Board voted to deny Mr. Thibodeau’s application. The Board further stated that he must complete the apprenticeship program or prove that a hardship exists before being approved to take the S-2 exam.
