Cyr only concerning the Administrative Hearing in the Matter of James R. Lathrop, Docket No. 06-958 and Alan R. Cyr, Docket No. 06-959.

### **NEWLY APPOINTED BOARD MEMBERS**

## WELL ABANDONMENT REQUEST

Letter dated 9/15/06 from Megan A. Hatt who resides at 119 Grassy Hill Road, East Lyme, CT, concerning abandonment of well at her residence.

The Board unanimously concluded that a Connecticut (W-1) Limited Well Water-Supply Drilling Contractor license holder will be required to perform the well abandonment.

## DCP TRADE ENFORCEMENT DIVISION REPORT

DCP Trade Enforcement Director Richard Maloney reported on a newly hired occupational trade inspector (Ray Fuoco), who has been administratively trained and is ready to go out into the filed, meeting with the Connecticut Building Officials Association, working with them closely enforcement wise, with an emphasis on reviewing building permits and performing sting operations, providing inspectors with on-going investigatory training on narrative report writing and evidence collection techniques. Mr. Maloney also reported that complaints are being investigated within thirty days of receipt and responses provided to respondents and consumers, and that thirty thousand dollars has been collected in civil penalties via the Assurance of Voluntary Compliance program.

The Board voted unanimously to require DCP Trade Enforcement Division Director Richard Maloney to provide the Board with a monthly complaint report concerning stipulation offerings.

#### DCP CONTINUING EDUCATION REPORT

DCP Attorney Elisa Nahas reports that plumbing continuing education audit letters for plumbers have gone out and second waive of letters will also be going out to plumbers concerning non-compliance of continuing education requirements.

### **OLD BUSINESS**

#### In the Matter of Thomas J. Charles Docket No. 06-31

A Formal Administrative Hearing was held on 3/16/06 and the hearing was concluded. The Board voted at their 3/16/06 meeting to a Civil Penalty in the amount of \$11,500.00, Restitution in the amount of \$6,500.00, and to suspend Mr. Charles' (P-1) Unlimited Contractor license until Mr. Charles has paid the Civil Penalty and Restitution concerning this matter.

Mr. Charles made a request for reconsideration of the Board's 3/16/06 decision, which was to be considered at their 9/16/06 meeting. Mr. Charles requested a continuation concerning his reconsideration request due to a death in the family and the Board granted Mr. Charles a continuation at their 9/16/06 meeting. The Board granted Mr. Charles a continuation to their next meeting scheduled for Thursday, November 16, 2006.

The Board voted unanimously to deny Mr. Charles' request for a continuance concerning this matter.

In the Matter of James R. Lathrop Docket No. 06-958

In the Matter of Alan R. Cyr Docket No. 06-959

A Formal Administrative Hearing was held on 7/20/06 and the hearing was concluded. The Board voted unanimously to consider investigating the whereabouts of Mr. Lathrop of unknown whereabouts, to be criminally requested by local authorities having jurisdiction to bring Mr. Lathrop to the Board. On behalf of Mr. Lathrop, the Board voted unanimously to a Civil Penalty in the amount of \$17,500.00 and Restitution in the amount of \$6,500.00. On behalf of Mr. Cyr, the Board voted unanimously to issue an Immediate Order of Discontinuance, Civil Penalty in the amount of \$17,500.00, Restitution in the amount of \$6,500.00, and suspend his (P-1 202824) Unlimited Contractor license for a period of (90) ninety days.

The Plumbing Board requested at their 9/21/06 meeting, to have to have their legal counsel (Raul Rodriguez, AAG) present at their next meeting scheduled for Thursday, November 16, 2006, in order to provide the Board his advise concerning their 7/20/06 meeting decision regarding this matter.

Assistant Attorney General Raul Rodriguez did not attend today's meeting. After further discussion concerning this matter at today's meeting, the Board voted unanimously to amend their 7/20/06 decision to reflect a Civil Penalty in the amount of \$17,500.00 against Mr. Lathrop. On behalf of Mr. Cyr, the Board voted unanimously to issue an Immediate Order of Discontinuance, Civil Penalty in the amount of \$17,500.00 and Restitution in the amount of \$6,500.00, and suspend his (P-1 202824) Unlimited Contractor license for a period of (90) ninety days, due to the fact that Mr. Cyr is the holder of the plumbing license and the actual contractor of record, as well as the individual who obtained the permit for the plumbing work performed concerning this matter. The Board further voted unanimously to deny any future continuances concerning this matter.

#### In the Matter of William Aiudi

Docket No. 06-2037

A Formal Administrative Hearing was held on 9/21/06 concerning this matter. The Board voted unanimously to continue this matter to their next meeting scheduled for Thursday, November 16, 2006, in order to have their legal counsel (Raul Rodriguez, AAG) present for his advice on this matter, in addition to having a representative from PSI present to testify as well.

Mr. Aidui's attorney provided a written response to the Board concerning this matter in which Mr. Aidui and his attorney did not appear at today's meeting. The Board voted unanimously to continue the hearing on this matter today. DCP Attorney Anthony Santoro provided state exhibit No. 5, which is a letter addressed to the Board from PSI Testing Services concerning this matter, state exhibit No. 6, which is a continuance letter addressed to Mr. Aidui, and respondent exhibit No. 1, which is a letter addressed to the Board from Mr. Aidui's attorney, explaining Mr. Aidui's inability to attend today's meeting.

After the conclusion of the hearing and further discussion concerning this matter at today's meeting, the Board voted unanimously to issue a Final Decision and Order consisting of a Civil Penalty in the amount of \$1,000.00, and that the matter be referred to the CT Chief States Attorneys office for criminal fraud
