3. Warren Sorrentino and Frank Marchetti, Sponsor

Mr. Sorrentino and Mr. Marchetti were asked to appear before the Commission, because Mr. Sorrentino applied for Certified Residential status in September 2003 and the application was reviewed and denied by the Commissioner on May 12, 2004. Mr. Sorrentino sent in supporting documentation to the Department, which was received on October 20, 2004, but was deemed unsatisfactory as criteria for Certified Residential Appraiser status.

Mr. Sorrentino and Mr. Marchetti were present for today's proceedings.

The Commission asked Mr. Sorrentino to provide an overview of his background to establish if he qualified to sit for the certified examination. After a lengthy discussion, Commission Francis Buckley, Jr., made a motion that Mr. Sorrentino sit for the certified examination. The motion was seconded by Commissioner Russell Hunter. NEW BUSINESS

1. The Commission requested that the Department issue a mailer notifying all appraisers of the new law requirements and that this task be performed 30 days from today's date. The notification to read as follows:

Re: Sponsorship of Provisional Real Estate Appraisers

Dear Real Estate Appraiser:

We are writing to advise you of a recent change in the Regulations of Connecticut State Agencies concerning real estate appraisers of which you should already be aware. Effective December 7, 2004, in Connecticut, a supervising appraiser may not sponsor more than three provisional appraisers. This revision was prompted by the need to ensure better supervision, training, and oversight by the supervisor over the provisional appraisers. Provisional appraisers may continue to work with more than one supervising appraiser.

Section 20-504-4(j) of the Regulations provides that:

- (j) A supervising appraiser shall have no more than three (3) provisional licensed appraisers at any one time unless the supervisor has first obtained a waiver of this subsection from the commission. Any waiver of this subsection shall:
- (1) Be for a specific maximum number of provisional licensed appraisers;
- (2) State the minimum number of supervising appraisers that must be maintained in order to retain the waiver:
- (3) Lapse at the end of the licensure period during which the waiver is granted or upon a failure to maintain the required number of supervising appraisers, whichever occurs first; and
- (4) Require a new waiver whenever provisional licensed appraisers' licenses are renewed.

We realize that this new regulation may necessitate changes in your business, and therefore, we will allow a period of transition to allow you an opportunity to implement any necessary changes. Please be advised that all certified real estate appraisers in Connecticut must be in compliance with Section 20-504-4(j) of the Regulations no later than May 1, 2005. We will monitor compliance and take enforcement action as necessary.

2. Commissioner Christopher Italia presented an anonymous complaint regarding a website company, www.sourceoneservices, soliciting Broker Price Opinions (BPOs).

The Commission asked the Department to investigate this matter. Commissioner Sean Hagearty commented that he would provide the language that addresses BPOs in the statute.

CE Cards:

Back on May 7, 2004, the Commission decided to discontinue the use of continuing education cards in lieu of having the CT-approved education providers produce and issue a Certificate of Completion on their official letterhead to any student who successfully completes a course. This decision was made based on Director Richard Hurlburt's comments at the meeting that the Department is looking into a new method whereby the education provider can access the Department's e-licensing system to upload the names of those students who took and successfully completed continuing education courses. The information is then collected by PSI Examination Services who in turn submits it back to the State to upload into the e-licensing system. An audit is then performed by the Department to determine who did or did not complete their continuing education for the cycle.

Based on the new process not being operational, the Commission decided to reinstate the use of CE cards and asked Examiner Edward McMahon to order them for the 2006-2008 appraisal cycle.

4. Commissioner Gerald Rassmussen requested that the Commission consider approving the online version of "Course 320: General Applications" offered by the Appraisal Institute.

After a brief discussion, the Commission granted this request and Commissioner Sean Hagearty stated that he would contact the Appraisal Institute to have the online course submitted to the Commission Secretary after it has been IDECC approved.
