#### **National Registry Report**

Ms. Kieft-Robitaille advised the Commission that there was no disciplinary action to report this month.

Ms. Kieft-Robitaille informed the Commission that The Final Rule pertaining to the Collection and Transmission of Annual AMC Registry Fees was published in the September 25, 2017 issue of the Federal Register.

#### **Mandatory Appraisal Law Course**

Ms. Kieft-Robitaille reported that the revised mandatory course is complete and has been distributed to the approved schools. The approved schools have been advised that the course may not be altered and becomes effective October 15, 2017.
