Meeting Called to Order 10:10 a.m. St. Joseph College School of Pharmacy

Commissioner Summa addressed the group, welcoming all to this month's meeting, including University of Connecticut School of Pharmacy Students and thanking Dr. Ofosu and the St. Joseph's College School of Pharmacy for hosting the October meeting.

Legal Matters

DN 11-715 During a routine inspection of a Walmart Pharmacy #10-2200 (PCY.2056), a Drug Control agent noticed that the pharmacy's controlled substances safe was left open. The pharmacy was given a verbal warning. Drug Control later found the safe open on two occasions. *The Department is recommending a \$2,000 civil penalty.*

A motion was made by Commissioner Inguanti, seconded by Commissioner Cangelosi and a vote of 4-1 was passed accepting the Agency's recommendation. (Commissioner Beaudin abstains; he expressed concern regarding the low fine, given the number of times Drug Control Agents were on the premise and provided the Pharmacy Manager with a verbal warning.)

New Cases – Since the September meeting, Attorney Schwane has received 2 Pharmacy Technician surrenders and 10 new cases (4 prescription errors, 3 drug diversions, and 3 confidentiality breaches).
