- Working on Bath House, replacing some plumbing
- Commercial Cleaners will clean kitchen on March 28, 2019
- Clearing all water lines
- Sun Shelter (1) needs to be rebuilt awaiting approval
- Need to replace floors in Infirmary and several Cabins awaiting approval of materials and will use some left-over materials to get by for the season
- Cres recommended tree trimming occur before the start of Camp; many broken and brittle branches are around camp
- Betsie spoke to using old sails to structure some sort of Sun Shelter
- Discussion as to how to make the idea feasible many approaches were suggested, and exploration of options will continue
