6. Camp Harkness Foundation:

A. Play Group

- Music therapist to work with dates decided or plan special sessions

- Stan expressed the need for discussions on how to move forward rather than focus on getting "back to normal" flexibility is important

- Heather expressed concern over cancelled family walk and its impact on fund raising
- She requested anyone familiar with virtual walks share info with her on how they are being run

- Moving old structure several suggestions were discussed regarding the best place to put it, but no decision was made

7. Old Business

A. Camp Report

i. Physical Plant:

- John reported; Working on phased re-opening of the Camp
- Some staff is not returning
- Wildflowers planted at front gate
- Catching up on past proposed activities
- Staff has been wonderful and flexible
- Going forward we must be aware of maintaining safety of Camp
- Entire Camp has been sanitized "portables" have been sanitized twice a day
- New signage has been added around the Camp
- Planned improvements for Cabins including painting
- Several repairs in Dorcus Lodge
- Beach road cleaned up; brush pushed back
- Family bathrooms will open soon
- MaryAnn and Bev voiced concern about difficulty using portables; Patricia West responded that she would address the issue
- Vicki asked about reopening the Play Scape; Patricia responded that it wasn't in the plan
- Several agreed that it would be a challenge to keep it sanitized

ii. Camp Usage/Events:

- Vicki gave the May report (see attached)
- Many scheduled events are still cancelled
- Several people have volunteered for gardens
- Phase 1 re-opening will start on June 12th for people to walk the grounds
- Phase 2 on June 19th pass holders are able to reserve tables
- Times will be: 9am-4pm for picnicking and 5pm-8pm for walking the grounds
- Beach to open on Saturday, June 27th with 50 occupants total; 5 guests per pass holder
- Individuals will be given bracelets at gate to monitor numbers and for staff to identify individuals on the grounds
- MaryAnn and Bev questioned how we can do activities at the Camp; Vicki will have a discussion with Joe and staff at Oak Hill

B. DDS Updates

- Patricia reported multiple committees are working on reopening
- Kudos to John and Vicki on their hard work with Camp reopening
- April asked if parents were on the reopening committee
- John shared that inspections are restarting to get everything in order many inspections had been waivered

C. Advocacy

- Medicaid providers did receive some Federal funding
- Much needed at State level with the challenge of lost revenue from closures
- Special sessions for the Legislature possible in July and August
