A. Play Group

- Parents would like to meet online without children, but it has been hard to schedule
- Possible online virtual activity is being planned with Music Therapist
- Families are asking about Summer Camp
- Plans are being made for a virtual online Summer Camp Fair to assist parents

B. Fundraising

- Heather reported that the online fund has \$516.17
- Heather asked if an application had been made for a grant for the Summer Play Group
- April responded funds from the last grant were still available; more would be accessed if needed

C. Sun Shelter

- Shelter is completed
- Continued work on electric and heating options is being done
- old shelter is still set aside
- Vicki thought that if the old shelter was placed near the Nature Trail, the Boy Scout project could be to clear the area where the shelter would be relocated
- John said that the site would need preparation additional stone needed to be put down

7. Old Business

A. Camp Report

i. Physical Plant:

- John reported a meeting will be held with maintenance team to discuss Spring & Summer
- Bev asked why the plants were cut down along the road to the beach
- John responded that the plants were invasive and were removed by DEP in an attempt to restore the marsh
- Waterford High School oceanography class project will be to put in an accessible dock for kayaking; the class wanted to offer the dock to the Camp

ii. Camp Usage/Events:

- Vicki gave December report (see attached)
- \$3355 in gift cards were collected and purchased through donations made through a virtual version of the 41st Annual Motorcycle Gift Run
- The Chiefs Club purchased gifts for 63 individuals from the wish list
- The traditional party for over 40 years was cancelled due to Covid-19 restrictions
- Special Events: 23 individuals

- Day Visitors: Unknown since Booth was closed for the Season
- Vicki suggested that there be some method of tracking Day Visitors
- There is a need to learn more about the gate system, but the company that installed it is no longer in existence
- John will further discuss with Vicki how to count/keep track of how many day visitors come to the Camp

B. DDS Updates:

- Stan reported that the reopening plan is status quo
- Hopefully impact from Covid-19 vaccinations will change the status

C. Advocacy

- Stan stressed the need to stay in touch with the new leaders in the legislature at the Capitol
- It was important to be aware of what bills are filed and what the legislature is trying to do
