# **Topics for Discussion**

#### Chairperson, Adrienne Benjamin, Update

Ms. Benjamin congratulated Council person Arlene Reith on her op-ed article, 'Sell Seaside, don't betray those in need' published March 13, 2018, in *the day* of New London.

Ms. Benjamin discussed the following legislative bills with the Council asking for support to unite the Council to present at the public hearing tomorrow.

- S.B. No. 400 (RAISED) PUBLIC HEALTH. 'AN ACT CONCERNING GRADUATE FUNDING AND THE PROVISION OF SUPPORT AND SERVICES FOR PERSONS WITH INTELLECTUAL DISABILITY', to ensure the provision of quality services to persons with intellectual disability.
- S. B. No. 296 (RAISED) PUBLIC HEALTH. 'AN ACT ESTABLISHING A PILOT PROGRAM TO SERVE PEOPLE SEEKING RESIDENTIAL SERVICES FROM THE DEPARTMENT OF DEVELOPMENTAL SERVICES', to establish a pilot program to better serve people waiting for residential services from the Department of Developmental Services.
- S. B. No. 463 (RAISED) PUBLIC HEALTH. 'AN ACT CONCERNING THE DEVELOPMENT OF A FACILITIES AND RESOURCES PLAN FOR PERSONS WITH INTELLECTUAL DISABILITY', to establish a task force to develop a facility and resource plan to meet the needs of persons with intellectual disability.

S. B. No. 218 (RAISED) PUBLIC HEALTH. 'AN ACT PROHIBITING INVOLUNTARY STERILIZATION OF PERSONS WITH DISABILITIES', to prohibit the involuntary sterilization of persons with disabilities.

The Commissioner, Rod O'Connor and Deputy Commissioner, Peter Mason, answered questions from the Council. The majority of the Council members voted in favor of supporting S. B. No. 296.

Ms. Benjamin stated that while there was broad support for S.B. No. 400, especially the guarantee for new grad funding, no vote was taken because of other complications in the bill.

## Commissioner, Jordan Scheff

The Commissioner gave a legislative update to the Council. The Commissioner stated Rod O'Connor, Legislative Liaison, sends out his legislative updates which are extremely informative and allow tracking of the bills and legislative information.

The Commissioner handed out a Level of Need (LON) distribution chart and discussed the information with the Council.

The Commissioner discussed and answered questions concerning the Community First Choice (CFC) program with the Council. The Commissioner stated he is working with colleagues from the Department of Social Services (DSS) and the Office of Policy & Management (OPM) to offer support in finding solutions to manage the ongoing problems within the program.
