

## DDS Legislative Update – April 13, 2011

**This legislative update is divided into three sections:**

**Note:** This update is not a comprehensive list of bills before the Connecticut General Assembly. DDS is tracking and assessing the bills listed below for their potential impact on DDS consumers, families and guardians, DDS employees and DDS providers.

**This legislative update shows the bills that are being tracked by DDS this session.**

As the legislative session goes forward, bills will be referred from legislative committees to the House or Senate. The House or Senate then may refer the bills to other committees or chose to vote on them. In these updates, the last action taken on a bill will be in **bold**. For a bill to become a law, both the House and the Senate must vote favorably on it by June 8, 2011 at midnight and the Governor must sign the bill into law.

### **Key to Legislative Terminology:**

**Vote to Draft** means a Proposed Bill will be drafted as a Committee Bill.

**Reserved for Subject Matter Public Hearing** means a bill will have a Public Hearing but the date of the Public Hearing is still to be determined.

**Change of Reference** means that the original committee is moving the bill to another committee without a Joint Favorable action.

**JF** means the committee reported the bill favorably to the House or Senate.

**JF Change of Reference** means the committee reported the bill favorably to another committee.

**JFS** means the committee reported the bill favorably to the House or Senate but with substitute language.

**JFS Change of Reference** means the committee reported the bill favorably to another committee but with substitute language.

A File Number (**File No.**) is a unique number given to a bill once it has reached the House or Senate Floor. A file copy of a bill with the file number has a plain-language description of what the bill's provisions do, written by the Office of Legislative Research and a fiscal note that explains what a bill would cost or save to implement, written by the Office of Fiscal Analysis.

A House or Senate Calendar Number (**House or Senate Cal. No.**) is also a unique number that is given to a bill once it reaches the House or Senate Floor. This number is used to hold the bill's place on either the House or Senate Calendar. If the bill is a House bill (H.B. 5000 or higher) or a Senate bill (S.B.1 to 4999) it first gets a Calendar Number from the chamber the bill originated in. Once a House bill is passed in the House, it goes

on to the Senate where it receives a Senate Calendar Number. Likewise once a Senate bill (with a Senate Calendar Number) passes the Senate, it goes to the House and receives a House Calendar Number.

**S.B. No. 885 (RAISED) PUBLIC HEALTH. 'AN ACT PERMITTING INQUIRY ACCESS TO THE DEPARTMENT OF DEVELOPMENTAL SERVICES' ABUSE AND NEGLECT REGISTRY FOR CHARITABLE ORGANIZATIONS WHICH RECRUIT VOLUNTEERS TO WORK WITH PERSONS WITH INTELLECTUAL DISABILITIES' File No. 120, Senate Cal. No. 118,**

to ensure that individuals with substantiated abuse or neglect allegations against persons receiving services from the Department of Developmental Services are not permitted to serve as volunteers for charitable organizations such as the Special Olympics.

No. 78,** to make technical changes to statutes that include autism related terminology and repeal a statute concerning the autism spectrum disorder pilot program which terminated on June 30, 2009.

**S.B. No. 9** (COMM) HUMAN SERVICES. 'AN ACT CONCERNING A STUDY ON MEDICAID ELIGIBILITY', to consider an increase in the Medicaid income eligibility level.

**S.B. No. 34** (COMM) INSURANCE AND REAL ESTATE. 'AN ACT PROHIBITING OFFSETS FOR DEPENDENT CHILDREN IN DISABILITY INCOME PROTECTION POLICIES' File No. 302, Senate Cal. No. 206, to prohibit offsets in disability income protection policies from including Social Security disability benefits received by dependent children of an insured.

**Proposed S.B. No. 62** SEN. MEYER, 12th DIST. **S.B. No. 103** (COMM) HUMAN SERVICES. 'AN ACT CONCERNING THE AVAILABILITY OF PODIATRY SERVICES UNDER THE MEDICAID PROGRAM', to include podiatry as an optional service available under the Medicaid program.

**REF. HUMAN SERVICES** Public Hearing February 10, 2011 **Human Services Committee JF Change of Reference to the Appropriations Committee.**

**Proposed S.B. No. 114** SEN. WITKOS, 8th DIST. 'AN ACT CONCERNING APPROVAL OR REJECTION OF COLLECTIVE BARGAINING AGREEMENTS BY THE GENERAL ASSEMBLY', to require state employee collective bargaining agreements to be voted upon by the legislature before they become

effective.

**REF. APPROPRIATIONS Bill died in the Appropriations Committee.**

**Proposed [S.B. No. 115](#) SEN. WITKOS, 8th DIST. 'AN ACT CONCERNING A DEFINED CONTRIBUTION RETIREMENT PLAN FOR STATE EMPLOYEES'**, to change the state employee retirement plan from a defined benefit plan to a defined contribution plan for newly-hired employees.

**REF. APPROPRIATIONS Bill died in the Appropriations Committee.**

**Proposed [S.B. No. 116](#) SEN. MCLACHLAN, 24th DIST. 'AN ACT PROHIBITING RECEIPT OF STATE RETIREMENT INCOME DURING TIMES OF REEMPLOYMENT WITH THE STATE'**, to prohibit the receipt of pension and salary payments from the state at the same time.

**REF. APPROPRIATIONS Bill died in the Appropriations Committee.**

**Proposed [S.B. No. 117](#) SEN. BYE, 5th DIST. 'AN ACT CONCERNING AN ALTERNATE ROUTE TO CERTIFICATION PROGRAM FOR EARLY CHILDHOOD EDUCATORS'**, to decrease the amount of time required to obtain a teaching certificate for early childhood educators by establishing an alternate route to certification program for such educators.

**REF. EDUCATION Bill died in the Education Committee.**

**Proposed [S.B. No. 120](#) SEN. BYE, 5th DIST. 'AN ACT CONCERNING A COORDINATED EARLY CHILDHOOD EDUCATION SYSTEM'**, to establish a means by which to coordinate the various entities and funding sources for early childhood education and services.

**REF. EDUCATION Bill died in the Education Committee.**

**Proposed [S.B. No. 129](#) SEN. LOONEY, 11th DIST. 'AN ACT CONCERNING THE PROHIBITION OF CAPTIVE AUDIENCE MEETINGS'**, to prevent captive audience meetings.

**REF. LABOR AND PUBLIC EMPLOYEES Bill died in the Labor and Public Employees Committee.**

**Proposed [S.B. No. 133](#) SEN. FRANTZ, 36th DIST. 'AN ACT RESTRICTING PROPOSED LEGISLATION TO A SINGLE SUBJECT MATTER'**, to allow the public to have a better understanding of proposed legislation by requiring bills to address only one subject matter.

**REF. GOVERNMENT ADMINISTRATION AND ELECTIONS Bill died in the Government Administration and Elections Committee.**

**Proposed [S.B. No. 134](#) SEN. MEYER, 12th DIST. 'AN ACT REQUIRING CRIMINAL BACKGROUND CHECKS OF ALL PERSONS EMPLOYED BY HOME HEALTH CARE AGENCIES AND HOMEMAKER-HOME HEALTH AIDE AGENCIES'**, to require criminal background checks of all prospective employees of home health care agencies and homemaker-home health aide agencies.

**REF. PUBLIC HEALTH** Change of Reference to Committee on Aging. **Bill died in the Aging Committee.**

Proposed [S.B. No. 145](#) SEN. DOYLE, 9th DIST. 'AN ACT CONCERNING THE CONNECTICUT UNIFORM ADULT PROTECTIVE PROCEEDINGS JURISDICTION ACT', to adopt a Connecticut Uniform Adult Protective Proceedings Jurisdiction Act.

**REF. JUDICIARY** Bill died in the Judiciary Committee.

[S.B. No. 148](#) (COMM) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT SUSPENDING THE REQUIREMENT FOR THE ALLOCATION OF FUNDS FOR ARTWORK FOR STATE BUILDING PROJECTS', to suspend for two years the requirement that the State Bond Commission allocate one per cent of the state building project cost for the purchase of artwork.

**REF. GOVERNMENT ADMINISTRATION AND ELECTIONS** Public Hearing March 7, 2011. Government Administration and Elections Committee JF to the Senate.

Proposed [S.B. No. 149](#) SEN. DOYLE, 9th DIST. 'AN ACT CONCERNING IMPROVED SOCIAL WORKER TO RESIDENT RATIOS IN NURSING HOMES', to improve the quality of care in the state's nursing homes by ensuring that such facilities employ social workers at a level that adequately addresses the needs of residents.

**REF. PUBLIC HEALTH** Change of Reference to the Aging Committee. **Public Hearing February 10, 2011. Bill died in the Aging Committee.**

Proposed [S.B. No. 158](#) SEN. WELCH, 31st DIST.; REP. BETTS, 78th DIST.; REP. NICASTRO, 79th DIST. 'AN ACT REQUIRING PUBLIC HEARINGS PRIOR TO THE APPROVAL OF NEW GROUP HOMES', to require a public hearing for new group homes.

**REF. PLANNING AND DEVELOPMENT** Bill died in the Planning and Development Committee.

Proposed [S.B. No. 159](#) SEN. WELCH, 31st DIST.; REP. BETTS, 78th DIST.; REP. NICASTRO, 79th DIST. 'AN ACT CONCERNING GROUP HOMES', to require notice of the construction or expansion of group homes to be given to certain public safety officials.

**REF. PLANNING AND DEVELOPMENT** Bill died in the Planning and Development Committee.

Proposed [S.B. No. 170](#) SEN. CRISCO, 17th DIST. 'AN ACT CONCERNING DENTAL BENEFITS IN A STATE HEALTH INSURANCE EXCHANGE', to require, upon the establishment and enactment of a state health insurance exchange, preventive dental benefits and additional dental services to be offered as options in health insurance plans sold through such exchange.

**REF. INSURANCE AND REAL ESTATE** Bill died in the Insurance and Real Estate Committee.

Proposed [S.B. No. 177](#) SEN. BOUCHER, 26th DIST. 'AN ACT CONCERNING COPAYMENTS UNDER THE STATE EMPLOYEES' HEALTH INSURANCE PLAN', to reduce the cost of providing state benefits by increasing copayments for all employees and officials.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 178](#) SEN. BOUCHER, 26th DIST. 'AN ACT CONCERNING ANNUAL COST-OF-LIVING ALLOWANCES FOR STATE EMPLOYEES', to postpone cost-of-living allowances for state employees during fiscal years when the state runs a deficit until such time as the state attains a surplus.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 179](#) SEN. BOUCHER, 26th DIST. 'AN ACT REDUCING THE SALARIES OF ALL STATE EMPLOYEES AND ELECTED STATE OFFICIALS', to reduce the salaries of state employees and elected state officials by ten per cent for two years.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 184](#) SEN. BOUCHER, 26th DIST. 'AN ACT CONCERNING THE "ANTI-SPIKING" PROVISION FOR CALCULATING STATE EMPLOYEE RETIREMENT INCOME', to reduce state pension costs by reducing the "anti-spiking" provision from thirty per cent to eighteen per cent over the previous two years' earnings.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 186](#) SEN. MARKLEY, 16th DIST. 'AN ACT IMPLEMENTING A DEFINED CONTRIBUTION PLAN FOR NEW STATE EMPLOYEES', to change the state pension system from a defined benefits plan to a less-costly defined contribution plan.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 187](#) SEN. SLOSSBERG, 14th DIST.; SEN. HARTLEY, 15th DIST.; SEN. DUFF, 25th DIST. 'AN ACT GRANTING POWER TO THE GOVERNOR TO BALANCE THE BUDGET', to provide the Governor with every option to balance the budget.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 188](#) SEN. MCLACHLAN, 24th DIST. 'AN ACT CONCERNING STATE EMPLOYEES RETIREMENT SYSTEM', to clearly define future retirement benefit costs.

**REF. APPROPRIATIONS** Bill died in the Appropriations Committee.

Proposed [S.B. No. 190](#) SEN. BOUCHER, 26th DIST. 'AN ACT CONCERNING RETIREE HEALTH INSURANCE', to redefine the "rule of 75" to a "rule of 80" for retiree health insurance and to increase the premium share for health insurance paid by retired state employees for every five years of service below twenty-five.  
REF. APPROPRIATIONS Bill died in the Appropriations Committee.

Proposed [S.B. No. 192](#) SEN. RORABACK, 30th DIST. 'AN ACT REDUCING SALARIES OF CERTAIN STATE EMPLOYEES AND OFFICIALS', to begin to address the state's budget crisis by reducing the salaries of all elected officials and certain state employees by at least five per cent.  
REF. APPROPRIATIONS Bill died in the Appropriations Committee.

Proposed [S.B. No. 193](#) SEN. BOUCHER, 26th DIST. 'AN ACT CONCERNING CONTRIBUTIONS TO THE STATE EMPLOYEES RETIREMENT FUND', to protect the future obligations of the state pension fund.  
REF. APPROPRIATIONS Bill died in the Appropriations Committee.

Proposed [S.B. No. 197](#) SEN. KANE, 32nd DIST. 'AN ACT CONCERNING CLINICAL CONSULTATIVE SERVICES PROVIDED BY THE DEPARTMENT OF CHILDREN AND FAMILIES', to attain cost reductions and improve efficiencies by requiring the Department of Children and Families to transfer clinical consultative services to private, community-based providers.  
REF. SELECT COMMITTEE ON CHILDREN Bill died in the Select Committee on Children.

Proposed [S.B. No. 229](#) SEN. MCKINNEY, 28th DIST.; SEN. FASANO, 34th DIST.; REP. CAFERO, 142nd DIST.; REP. CANDELORA, 86th DIST.; REP. KLARIDES, 114th DIST. 'AN ACT CONCERNING CERTAIN AGREEMENTS OR STIPULATIONS REQUIRED TO BE APPROVED BY THE GENERAL ASSEMBLY', to require a vote by each chamber on all state employee collective bargaining agreements and all agreements or stipulated agreements under section 3-125a of the general statutes.  
REF. APPROPRIATIONS Public Hearing April 5, 2011. Bill died in the Appropriations Committee.

Proposed [S.B. No. 230](#) SEN. MCKINNEY, 28th DIST.; SEN. FASANO, 34th DIST.; REP. CAFERO, 142nd DIST.; REP. CANDELORA, 86th DIST.; REP. KLARIDES, 114th DIST. 'AN ACT CONCERNING HEALTH INSURANCE COPAYMENTS AND PREMIUMS PAID BY STATE EMPLOYEES AND OFFICIALS', to create parity between state and private health insurance plans.  
REF. APPROPRIATIONS Bill died in the Appropriations Committee.

Proposed [S.B. No. 276](#) SEN. HARP, 10th DIST. 'AN ACT PROHIBITING FORMER STATE EMPLOYEES FROM SEEKING, ENTERING INTO OR NEGOTIATING STATE CONTRACTS', to prevent former state employees from seeking, entering into or negotiating contracts with a state agency for three years after



leaving state service.

Proposed [S.B. No. 292](#) SEN. KANE, 32nd DIST. 'AN ACT CONCERNING MEDICAID COVERAGE FOR PERSONS WITH AUTISM', to obtain a waiver of Medicaid rules to allow improved and earlier diagnosis and treatment of autism.

No. 278, to require the Commissioner of Social Services to amend the Medicaid state plan under Section 1915(i) of the Social Security Act.

'AN ACT CONCERNING EMPLOYER NOTICE TO EMPLOYEES REGARDING MANDATORY OVERTIME', to require an employer to provide employees with twenty-four-hour notice if such employees are going to be required to work more than eight hours of overtime in a single pay period.

**REF. LABOR AND PUBLIC EMPLOYEES** Public Hearing February 15, 2011. **Bill died in the Labor and Public Employees Committee.**

[S.B. No. 366](#) (RAISED) AGING. 'AN ACT CONCERNING FUNDING FOR ADULT DAY CARE CENTERS', to increase rates paid to adult day care centers.

**FUNDING'**, to provide equal funding of special education excess costs to local and regional school districts.

Proposed [S.B. No. 448](#) SEN. FRANTZ, 36th DIST. '**AN ACT CONCERNING THE STATE EMPLOYEES RETIREMENT COMMISSION**', to help ensure that the State Employees Retirement Commission adopts a realistic assumed rate of return for its investments.
