June 2022 Monthly Report to the Council on Developmental Services

Assistance to Individuals and Families

In relation to my duties as Ombudsperson I worked with individuals, families, advocates, DDS, legislators and outside agencies on numerous issues including:

- 1. Inquiries about abuse & neglect process and reporting.
- 2. Referrals to DDS Helpline.
- 3. Assistance to individuals on waiting list & families pursuing less traditional housing options and living.
- 4. Assistance to parents & family members with private & DDS provider complaints.
- 5. Assistance with ADA & other inquiries.
- 6. Continued assistance to family, private Support Broker, The Arc, & DDS to support individual in moving into his own home.
- 7. Continued work with guardian & DDS to expand access and visitation for family member.
- 8. Assistance to family who self directs with issues with fiscal intermediary.
- 9. Assistance to out-of-state social worker who is supporting an individual moving to CT.
- 10. Assistance with DDS eligibility questions and issues.
- 11. Assistance families of hospitalized individuals.
- 12. Assistance to family with individual decompensating in the family home.
- 13. Inquiries about cameras in programs.
- 14. Assistance to families that have been removed as guardians.
- 15. Contact from legislator on behalf of constituent with complaints about DDS & private provider.
- 16. Contact from DCF regarding abuse & neglect complaint.

- Monthly meeting with DDS Health Management Administrator.
- Met with DDS qualified providers to discuss services offered.

- Consulted with West Region & private provider re: individualized day supports.

Areas of Concern

- Impact of staffing crisis on ability to access supports, person centered planning, advocacy, provider flexibility.
- Impact of loss of staff and experience, particularly at STS and Regional Centers due to state employee retirements.
- Maintaining active family involvement, advocacy and support for individuals who receive residential supports outside of the family home through DDS or private providers.
- Supporting, protecting and encouraging individual and family advocacy.
- Provider accountability.
- The lack of support options for individuals with autism and intellectual disabilities who are not eligible for DDS funding.
