Maternal-Child Clinical Experience

- Focus on maintaining wellness
- Prevention of complications for mother and child
- Understand the role of the health care team in a variety of settings, including clinic, home, school, medical care facility (including hospital, office, etc)

Observational experience goals

- □Verbalize an understanding of the psycho-social and spiritual needs of the family with a child with developmental needs.
- Identify learning needs and priorities of the family.
- □ Discuss the role of a nurse in the Maternal-Child outpatient setting.

Observational experience goals

- Identify family concerns, including resources and supports
- Research community resources that are available to families of children with developmental needs.



Student Assignment

- Identify the role of the nurse in the setting observed.
- Compare & contrast the growth & development of a healthy child to the child with challenges and issues that may impact their overall health, wellness, and ability to grow or thrive.
- Discuss how the family has been affected by the child's status.
- Identify family support systems.
- Discuss the role of support systems in family dynamics.



- Discuss the roles of various multidisciplinary team members who are involved family education and the provision of services
- Write a personal reflection of this experience including:
 - how the experience with the client affected you on a personal and professional level
 - how the experience affected your knowledge of normal and abnormal growth & development
