### Provider Description

**Information provided by the provider describing their agency:**

I am an Independently Contracted/Private-Hire Qualified Behaviorist for consumers receiving DDS and DSS Autism Division In-Home Behavioral Supports. I work with both children and adults on my caseload, as well as with their families and staffs for training and support. Positive Behavioral Support Plans are created after I conduct FBA, and focus on psychoeducation and practice of adaptive replacement behaviors. This includes development of healthy coping skills for the consumer to reduce problematic behaviors (including those that are safety-compromising). The priorities of family concerns for their child (the consumer) are always included, as part of Person-Centered Planning and support. I create visual supports for individuals whom are non-verbal or have processing delays/challenges with reading words. I meet the family, staffs, and consumer "where they are at," meaning not just geographically. The Behavior Plan is utilized when I conduct initial and ongoing training with family involvement, and as I supervise support staffs. I work directly with the individual being supported, in a firm but fair manner. The Behavior Plan focuses on how to help the individual make progress towards IP goals, which increases the consumer's quality of life and independence. I have resources from my professional experience to provide families with other providers they wish to incorporate, such as if the team would like to pursue a Neuropsychological Evaluation for the individual being supported. I am a Behavioral Supervisor for an agency, and bring those necessary leadership qualities, as well as Emotional Intelligence/Agility, into all of my work. I will attend IPs, PPTs, psychiatry appointments, etc. as needed and requested. As a private-hire, I am available to your family 7 days/week.
