The records of the Department of Transportation ("Department") indicate you are the holder of Permit No. 736. The records of the Department further indicate that you are in violation of following Connecticut General Statutes Sections (C.G.S.) and/or Regulations of Connecticut State Agencies, Connecticut General Statutes Sections 13b-102, 13b-103 and 13b-106, as amended, by violating the terms of the permit which requires the permit holder to comply with all pertinent motor vehicle laws and other statutes, and/or rules, regulations and orders of the Department.

More specifically, Metropolitan Livery applied for a headquarters address change. An investigator was sent on February 3, 2011 to conduct a records check as required. The investigator found that the office was not open, he called and talked to a dispatcher (Jasmine) and was told that their office was located in West Haven and no one was in the Meriden office. This is a direct violation of Regulations of Connecticut State Agencies:

Section 16-325-1 (1), (2), and (3) by failing to maintain an active headquarters; Section 16-325-3 failing to notify the department in writing within 48 hours of any change of business address.

Section 16-325-4 by changing location of its headquarters to a point outside of the city or town specified in its permit without prior approval by the Department.

Additional inspections were conducted February 23, 2011 and February 28, 2011 and it was found that the office was not operating.

Therefore, pursuant to Connecticut General Statutes Section 13b-102 through 13b-109, as amended, you are hereby directed to appear at the Newington office of the Department of Transportation, 2800 Berlin Turnpike, Newington, Connecticut, Conference Room B on Wednesday, May 11, 2011 at 10:00 a.m. for a citation hearing to show cause why this permit should not be suspended, revoked, and/or a civil penalty imposed for failure to comply with the applicable provisions of the Connecticut General Statutes and/or the Regulations of Connecticut State Agencies as stated above.
