Pursuant to Connecticut General Statutes Sections 13b-343 and 4-177 through 4-182, the Office of Rail, petitioner, requests to approve the repositioning of the active warning devices due to a reconfiguration of the private drive that enters the crossing area onto Route 106 (Hoyt Street) just South of the existing crossing. Flasher poles with flashers and the vehicle gate will need to move to a more desirable location for the vehicles that use the private road to access Hoyt Street from the private Cedar Lane Development.

Anyone may petition the department to obtain party or intervenor status in accordance with Connecticut General Statutes Section 4-177a and Regulations of Connecticut State Agencies Section 13b-17-141a as follows:

## **PARTY STATUS:**

- 1. A written petition must be submitted to the agency;
- 2. A copy of such petition must be mailed to all know parties (usually the Petitioner); and
- 3. The petition must state facts that demonstrate that the petitioner's LEGAL RIGHTS, DUTIES OR PRIVILEGES will be SPECIFICALLY AFFECTED by the agency's decision.

## **INTERVENOR STATUS:**

- 1. A written petition must be submitted to the agency;
- 2. A copy of such petition must be mailed to all known parties (usually the Petitioner) and

3. The petition must state facts that demonstrate that the Petitioner's participation is in the INTEREST OF JUSTICE AND WILL NOT IMPAIR THE ORDERLY CONDUCT OF THE PROCEEDING.

All petitions and certification of party notification must be received by this agency five (5) days prior to the date of hearing; otherwise such requested status shall be subject to denial.

An original and FOUR (4) copies of all prepared documents and exhibits intended to be introduced as evidence in this matter by the Petitioner and any other party or intervenor must be filed with the Department not less that FIVE (5) days prior to the date of hearing. All filings must be mailed or delivered to:
