Pursuant to the provisions of 13b-97 and 4-177 thru 182 of the Connecticut General Statutes, the following taxicab operators seeks authorization to increase the under fifteen mile taxicab meter rate within and to and from the towns of Ansonia, Ashford, Avon, Beacon Falls, Berlin, Bloomfield, Branford, Bridgeport, Canton, Colchester, Cromwell, Derby, Durham, East Granby, East Haddam, East Hampton, East Hartford, East Haven, East Windsor, Eastford, Ellington, Enfield, Farmington, Glastonbury, Granby, Guilford, Haddam, Hamden, Hartford, Hebron, Killingly, Lebanon, Manchester, Marlborough, Meriden, Middlefield, Middletown, Milford, Monroe, New Britain, New Haven, Newington, North Branford, North Haven, Orange, Oxford, Pomfret, Portland, Putnam, Rocky Hill, Salem, Seymour, Shelton, Simsbury, Somers, South Windsor, Stratford, Suffield, Thompson, Tolland, Trumbull, Vernon, Wallingford, West Hartford, West Haven, Wethersfield, Windsor, Windsor Locks, Woodbridge, Woodstock.

The taxicab rates:

Drop	\$2.25 first 1/9 <sup>th</sup> mile
Travel Rate	\$0.25 each 1/9 <sup>th</sup> mile
Waiting Time	\$0.25 for 29 seconds

Also in some towns:

Drop	\$1.75 first 1/10 <sup>th</sup> mile
Travel Rate	\$0.30 each 1/10 <sup>th</sup> mile
Waiting Time	\$0.30 each 35 seconds

Also in some towns:

Drop	\$2.00 first 1/8 <sup>th</sup> mile
Travel Rate	\$0.25 each 1/8 <sup>th</sup> mile
Waiting Time	\$0.25 each 36 seconds

And the statewide fuel surcharge program.

There have been these different rate requests by the petitioners:

The proposed rate increases are:

**PROPOSED RATE #1-by some companies**

**PROPOSED RATE #2-by some companies**

\$3.25 first 1/9<sup>th</sup> mile  
\$0.30 each 1/9 mile  
\$0.30 for 29 seconds

\$3.25 drop  
\$0.30 each 1/10 mile  
\$0.30 for 29 seconds (\$37.00 per hour)

With no fuel surcharge until the fuel price is least \$5.00 a gallon and then a \$0.01 increments for travel only.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case.

In addition, any person may request intervenor status if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.

All petitions for party or intervenor status must be submitted in written form and received by this department no later than five (5) days prior to the date of hearing. Otherwise, such requested status shall be subject to denial. The five-day requirement may be waived at any time before or after the commencement of the hearing on a showing of GOOD CAUSE. Copies of any requests for party or intervenor status must be mailed to the applicant and to all known parties.

An original and **FOUR (4) COPIES** of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party, or intervenor must be filed with the department no less than **SEVEN (7) DAYS** prior to the date of hearing. All filings must be mailed to:
