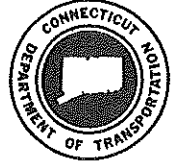

Pursuant to the provisions of Sections 13b-97 and 4-177 through 182 of the Connecticut General Statutes, Casino Cab Company, Inc. d/b/a Yellow Cab Company (hereinafter "applicant"), holder of Taxicab Certificate 225, is currently authorized to operate the following:

38 taxicabs within and to and from Bridgeport,
4 taxicabs within and to and from Fairfield,
3 taxicabs within and to and from Stratford,
3 taxicabs within and to and from Trumbull.

1. The applicant seeks to combine its territories of Bridgeport, Fairfield, Stratford and Trumbull, thereby operating its existing 48 taxicabs within and to and from the combined territory of Bridgeport, Fairfield, Stratford and Trumbull; and
2. Further, the applicant seeks to operate six (6) additional vehicles within and to said combined territory, for a total of fifty-four (54) taxicabs within and to and from the combined territory of Bridgeport, Fairfield, Stratford, and Trumbull.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case.

In addition, any person may request intervenor status if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.

All petitions for party or intervenor status must be submitted in written form and received by this department no later than five (5) days prior to the date of hearing. Otherwise, such requested status shall be subject to denial. The five-day requirement may be waived at any time before or after the commencement of the hearing on a showing of GOOD CAUSE. Copies of any requests for party or intervenor status must be mailed to the applicant and to all known parties.

An original and **FOUR (4) COPIES** of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party, or intervenor must be filed with the department no less than **SEVEN (7) DAYS** prior to the date of hearing. All filings must be mailed to:


